Sir,
With due respect, I am producing herewith the arrested accused person namely Khagen Barman (65 yrs) S/O late Dhanbar Barman of Thakur Nagar Rail Colony, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 19 (Nineteen) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
2. 05 (five) bottles of TUBORG premium Beer containing 650 ML in each bottle of Rs 141/- of each bottle.

I beg to state that today i.e. on 05.06.21 at 00.15 hrs I received a secret source information that one person named Khagen Barman of Thakur Nagar Rly Colony is selling ID liquor at his residence at Thakur Nagar Rly colony for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 176 dated 05.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava, CV/824 Niru Kr Yadav and CV/116 Rohit Kr Mahato left for Thakur Nagar Rly to work out the information in hand. At about 00.45 hrs we arrived at the house of accused Khagen Barman of Thakur Nagar Rail Colony, PS- NJP, Dist.- Jalpaiguri and being shown and identified by the source we managed to intercepted one person who disclosed his name and identity as Khagen Barman (65 yrs) S/O late Dhanbar Barman of Thakur Nagar Rail Colony, PS- NJP, Dist.- Jalpaiguri and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Khagen Barman S/O late Dhanbar Barman of Thakur Nagar Rail Colony, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 01.05 hrs to 01.35 hrs.


Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Khagen Barman (65 yrs) S/O late Dhanbar Barman of Thakur Nagar Rail Colony, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
