Sir,

In producing herewith one accused person namely Bishnu Oraon (38 yrs), s/o – Lt. Sani Oraon, of Thiknivita, PO- Menghora, PS- NJP, Dist - Jalpaiguri under arrest along with seized articles viz (i) 18 (eighteen) sealed bottles of 60 up Country sprit each bottle containing 600 ml and styled as "Boss" (ii) 09 (nine) sealed bottles of "Kingfisher Strong premium beer" containing 650 ml each. (iii) 07 (seven) sealed pouch of "Officer Choice Delux Whisky" containing 180 ml. each (Total amount of which is Rs-3950/-). I ASI Dipak Singha of Milanpally OP under NJP PS/SPC do here by lodged a written complaint to the effect that today on 05/06/21 at 13:55 hrs acting on a tip-off source information myself along with ASI Biswajit Adhikari, C/- 1052 Dipak Das, C/-959 – Dijen Chandra Roy had been to Thiknivita boarding in a PS govt. Vehicle to work out the information that a huge number of country sprit are stocked in the shop of one Bishnu Oraon (38 yrs), s/o – Lt. Sani Oraon, of Thiknivita, PO- Menghora, PS- NJP, Dist - Jalpaiguri without license to sale the same in local liquor selling dens. This refers to Milanpally OP GDE No-109, dt-05/06/21. On arrival at Thiknivita I summoned two local witnesses to witness the raid and on being identified by the engaged source we held raid in the shop of Bishnu Oraon and could recover the above noted huge amount of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. The entire articles were kept hidden in a big size nylon bag. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused person and took into the custody. The seizure and label was made in between 14:35 hrs to 14:45 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Bishnu Oraon (38 yrs), s/o – Lt. Sani Oraon, of Thiknivita, PO- Menghora, PS- NJP, Dist – Jalpaiguri.
