In producing herewith one accused person namely Mani Kumar Chetri (39) S/O Man Bahadur Chetri of Farabari, Nepalibusty PS- NJP-Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Two (02 ) Bottles of Mc Dowells no.01 superior whisky partly filled .
2. One (01) Bottles of Royal Challenge premium gold whisky partly filled.
3. One (01 ) Bottles of Royal stage blended whisky partly filled.
4. Fourteen (14 ) Bottles of Himalayan gold 60up country sprit (each bottle containing 600 ML) .

I, SI Rakesh Debnath of Ambari Falakata out post under NJP PS ,SPC lodged a written complainant against the above noted person to the effect that today i.e. on 05.06.2021 at 15.35 hrs received a source information that at the house of Mani Kumar Chetri (39) S/O Man Bahadur Chetri of Farabari, Nepalibusty PS- NJP Dist- Jalpaiguri has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata out post GDE no-180 dated 05.06.21. I informed to O/C Ambari Falakata out post about the information . As per his kind instruction I along with, VP/14 Paritosh Roy, CVF/963 Tapan Roy, CVF/001 Jay Chand Roy ,CVF/483 Khirmohan Roy . proceed to . Nepalibusty to work out the information. At 16.05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Mani Kumar Chetri and recovered the above noted articles from the possession of above noted accused person namely Mani Kumar Chetri (39) S/O Man Bahadur Chetri of Farabari, Nepalibusty PS- NJP Dist- Jalpaiguri . On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Rabi Thapa S/O Ramesh Thapa of Durgaguri, PS-Pradhanagar Dist-Darjeeling 2. Subhash Sarkar (50) S/o Lt Narayan Sarkar of Mahamaya colony PS-NJP Dist-JPG. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 16.15 hrs to 16.40 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Mani Kumar Chetri (39) S/O Man Bahadur Chetri of Farabari, Nepalibusty PS- NJP Dist- Jalpaiguri under proper section of law.
