Sir,

In producing herewith two accused persons namely (i) Guddu Basfore (22) s/o Lt. Umesh Basfore rear side of Railway Hospital, Ward No. 32, PS- NJP, Dist.- Jalpaiguri and ii) Sona Singha (18) S/o Ganga Singha of Shanti Para, Rathkhola More, PS- NJP, Dist.- Jalpaiguri along with the following seized articles under seizure as per seizure list:

- 1) One packet weight 13 kg 700 grams said to be Ganja wrapped by a black colour Tape Marked as Exhibit "A"
- 2) One Red colour bag styled as "ELLE DOT96" where "Exhibit A", was kept. Marked as "Exhibit B"

Exhibit "A" found inside Exhibit "B" from possession of Guddu Basfore and Sona Singha who were carrying one bag by catching two handle by both of them.

Total weight of the said to be ganja (Exhibit A,) is 13 Kgs 700 gms.

I, SI Pintu Ghosh of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that on today i.e 05.06.2021 at 17.05 hrs I received a specific source information that two persons would be coming from Cannel Road side to Bhalobasha more, a suspected consignment of Ganja procured from containing in one bag for disposing the same at New Jalpaiguri area. I accordingly shared the information through messenger to SI Samir Tamang, O/C New Jalpaiguri PS, Siliguri Police Commissionerate and as per his kind direction, diarized the fact in GD vide New Jalpaiguri PS GDE No 215 Dated 05.06.2021. Consequently, at 17.05 hrs, myself along with C/1438 Kamal Barman and C/1440 bappaditya Roy all left for Bhalobasha More to verify the veracity of the information vide GDE No 215 dated 05.06.2021 by Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 17.25 hrs we reached near Bhalobasha more and parked the vehicle at considerable distance and proceeded towards Bhalobasha more. Meanwhile, I called two disinterested witnesses namely 1) Haridas Biswas s/o Lt. Hare Krishna Biswas of Fulbari Bazar, PO Fulbari, PS NJP, Dist. Jalpaiguri, 2) Sher Ali s/o Lt. Najibuddin of Chunabhati, PS NJP, Dist. Jalpaiguri. I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any. Meanwhile, our Police party started looking for accused persons and finally two persons came at Bhalobasha More, we could notice that both the persons carrying one bag by catching two handle by both of them. On seeing us they tried to flee away but somehow we could managed to apprehended them and detained them with a strong reason to believe that they possesses illegal said to be Ganja in the bag and the secret source information seemed to be matched with appearance of said person. I disclosed our identity to them. On being asked they disclosed their name and address as noted above and also admitted that they are possessing contraband drugs in that bags. I, then, gave them option that whether they wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer. They agreed to be searched in presence of police Gazetted Officer. Accordingly, I served the Notice in writing as per provision of Law to them which they duly acknowledged by receiving and signing in the copy of Notice. Accordingly, I informed Sri. Manish Kumar Yadav, ACP Traffic East, Siliguri Police Commissionerate rewarding the apprehension of said persons with contraband drugs and requested him through messenger to come at Bhalobasha More, NJP and remain present as Gazetted Officer during the time of search and seizure if any which he duly accepted. At 18.05 hrs Sri. Manish Kumar Yadav, ACP Traffic East, Siliguri Police Commissionerate arrived at the spot in uniform and
