Sir,

With due respect, I am producing herewith the arrested accused person namely Babu Das (45 ) S/O late Anil Das of NJP Bhakti Nagar, Near Agrani Sangha Club, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 54 (Fifty four) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.

I beg to state that today i.e. on 05.06.21 at 18.45 hrs I received a secret source information that one person named Babu Das of NJP Bhakti Nagar is selling ID liquor at his shop at Bhakti Nagar Bajar for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 219 dated 05.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, VP/13 Jamirul Islam and CV/306 Biswajit Roy left for Bhakti Nagar Bajar, NJP to work out the information in hand. At about 19.15 hrs we arrived at NJP Bhakti Nagar Bazar and being shown and identified by the source we held raid and managed to intercepted one person who disclosed his name and identity as Babu Das (45 ) S/O late Anil Das of NJP. Bhakti Nagar, Near Agrani Sangha Club, PS- NJP, Dist.- Jalpaiguri and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Babu Das (45 ) S/O late Anil Das of NJP Bhakti Nagar, Near Agrani Sangha Club, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 19.45 hrs to 20.35 hrs on 05.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Babu Das (45 ) S/O late Anil Das of NJP Bhakti Nagar, Near Agrani Sangha Club, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
