I, Si Sibdhan Karmakar Bhaktinagar PS/SPC lodged a written complainant against the above noted accused persons to the effect that on 04.06.2021 at 15.45. hrs in course of performing lock down mobile van duty at Sevoke Road, under Bhaktinagar P.S, Jalpaiguri in order to restrict the unnecessary movement of vehicular traffic for combating the spread of Covid-19, and received an information that huge number of official staff are working without any COVID vaccination in CG FOODS (Wai Wai Office) situated at GEM House 4th floor Sevoke Road, near Marwari Bhawan. Accordingly I along with ASI Biswajit Saha, LC 1348 Menuka Rana, LC 1248 Puja Tamang, CV-935 Biplab Roy and CV-614 Sumit Roy had been to above noted place to work out the information. On reaching at spot I found that the huge number of male and female staff of CG FOODS (Wai Wai Office) were working without maintaining any social distancing and without wearing any mask and further enquiry it could be learnt that they had not taken any COVID vaccination. On being asked they disclosed their identity as noted above and they stated that they were well aware of lock down and pandemic Covid-19 situation and they supposed to wear face mask. Further I requested them to wear Mask and maintain the social distance but they did not pay any heed. Hence they all violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-I (A), Govt. of India Ministry of Home Affairs Dated 24.03.2020. They all also violated the order of Govt. of India duly promulgated in order no 40-3/2020-DM-I (A), Govt. of India Ministry of Home Affairs Dated 24.03.2020 and MHA (Internal Security Division) vide no- 11034/01/02022-IS-IV Dt. 27/04/20 & Govt. of WB order No - 79-CS/2020 Dated- 12.04.2020 and advisory issued vide no- 715-Home 9Cons)/RIM
