Sub: Complain Against Sri Dipak Dutta And His Staff Kishore Sarkar (Babu ) And His Wife Sampa Dutta

Respected Sir

I smtMoumita Banerjee aged about 32 years w/o sri Raju Banerjee is a resident of B.ED College Road, Bara Mohan Singh Jote, PO Kadamtala PS Matigara, Darjeeling beg to report you the following facts.

1. Sri Dipak DUTTA s/o Late Parikshit Dutta R/O B.ED College Road, Bara Mohan Singh Jote, PO Kadamtala PS Matigara, has his house beside the house of me.
2. Since several months the above named Dipak dutta voluntarily Parking / Keeping his Private Four Wheeler Car/Vehicles just in front of the said main gate of us causing obstructions to me and my family member from egress and ingress to my house Premises. Even he illegally use to wash his car/vehicles by water with soap within the boundary premises of mine, criminally trespassing to the house boundary premises, which lead dirty water enter into the premises and caused rusting of iron Rod of Main gate and slippery in front of the main gate due to which many of times we and outsiders slipped including my 12 year son.
3. Several Times I and my husband Sri Raju Banerjee requested him and his driver not to do so, but he did not care our request.
4. On 23<sup>rd</sup> Jan 2021, while his driver was washing the car I and my Husband again requested his driver and him that not to wash the INNOVA car ( WB 74V2608 ) in front of main gate of my premises, DIPAK DUTTA and his wife Smt Sampa Dutta approach towards my husband in the fit of rage for physical assault for refraining to do so and threat me and my Husband that he will continue to park his Cars and will also instruct all his tenants ( approx. 7 to 8 families ) to continue to park cars, cycle and bike in front of my gate by commenting he will cut my husband into pieces and set fire our house and murder my husband by hiring goons. Even though his wife is also constantly abusing me by filthy , insulting and obscene language .

On the very Next day ( 24<sup>th</sup> Jan 2021 ), he again Park his scorpio vehicles (WB73E3463 ). In front of my front gate both Morning and evening, following his threat which he gave just one day earlier.

6. FROM 24<sup>th</sup> Jan 2021 he continuously park his car to provoke and intentionally inviting us for quarrels. ( cctv Footage as evidence ) but I and my Husband handled the situation patiently and peacefully to avoid any quarrel for the sake of reputation and prestige
7. On 27<sup>th</sup> Jan 2021 I again request driver Kishore Sarkar politely not to park scorpoinfront of my gate , But suddenly he losses his temper and said " TOR BAPER JYEGA NAKI, EKDOM CHUP CHAMRA KHULE DEBO . and after that he make a verbal sexual harassment with sexual comments and making sexual gesture through finger movement towards me. This all happened in front of shri Dipak dutta.
8. For their Acts and activities I along with my family members are passing our days in unrest and in fear our safety and security is under threat because of such fact being caused by them.
9. Moreover in the month of February, when I and my husband along with my son are on the evening walk in the flyover of chiriya More, Kadamtala his driver Kishore Sarkar suddenly stop his scorpio vehicle and used threatening language by saying " TOR BARI TE AMRA BANDUK O BEAINI JINIS DHUKIE PHASIE DEBO "
10. Moreover Dipak Dutta purposely/ intentionally leash his pet dog in front of the window of my bedroom and kitchen which resulted in immense disturbance due to barking and potty related issue to my family, I can't open the window due to awful smell at present yet
11. TILL date of writing the diary. No problems are being sorted out and still continuous.

I therefore request you kindly take necessary steps against sri Dipak dutta, his staff Kishore Sarkar and his wife smtSampadutta. For their commission of such offence.
