Sir,

In producing herewith one accused person namely; Pankaj Sharma (38) S/O- Dinesh Sharma of Shantikunj near Mansha Singh Compound, Ward No- 41, Sevoke road near Don Bosco More, PS- Bhaktinagar, Dist- Jalpaiguri under arrest along with the following seized articles under seizure along with seizure list :-

- (i) 30 (thirty) bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup, Lykarex Cough Syrup each bottle containing 100ml. manufactured by CADIZ LIFE SCIENCE ,39/2/6 ,Site IV ,Industrial area, Sahibabad ,Ghaziabad-201005 (U.P) marketed as exhibit "A " out of which one bottle taken as sample and marked as Exhibit "A-1".
- (ii) 07(seven) bottles of Codeine Phosphate & Chlorpheniramine Maleate Syrup Rc Kuff cough Syrup each bottle containing 100 ml. manufactured by Wings Pharmaceuticals PVT, Ltd. 43 & 44 , HPSIDC Industrial area Baddi ,173205 (HP) , marked as Exhibit -B out of which one bottle taken as sample and marked as Exhibit "B-1".
- (iii) 08 (eight) strips of Spasmo-Proxyvon plus capsules each stripes containing 24 capsules, manufactured by Akums Drugs & Pharmaceuticals Ltd. Marked as Exhibit-"C" out of which one strip taken as sample and marked as exhibit-"C-1".
- (iv) One sky blue colour bag wherein written Lenovo in which the seized articles were kept as per seizure list, marked as Exhibit - "D".

I SI Sibdhan Karmakar of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodged this complaint against Pankaj Sharma (38) S/O- Dinesh Sharma of Shantikunj near Mansha Singh Compound, Ward No- 41 ,Sevoke road near Don Bosco More PS- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 07.06.2021 at about 20.51 hrs received an information from my secret source that one person is selling Cough Syrup and Drug tablets in his Medicine Shop name as style as "Sanjeevani Medico" near Don Bosco more under Bhaktinagar Police Station with huge quantity of drugs in his possession without valid documents for the purpose of selling to the drug addicted people and students of schools and colleges, which were fraudulently obtained by him. Accordingly the information is diarized vide Bhaktinagar P.S.GDE 419 Dated- 07.06.2021 and informed the fact to I/C Bhaktinagar P.S. and as per kind order myself along with, ASI Biswajit Saha , ASI Biplab Kumar Das , CV-619 Dharmendra Roy and CV-614 Sumit Roy all of Bhaktinagar P.S. left for Don Bosco More as per Bhaktinagar P.S. C.C No-1368 date 07.06.2021 to verify the veracity of information. At about 21.10 hrs while myself along with party reached at the spot and as shown and identified by the source, we cordoned the medicine shop and found the above noted person was selling something to some person. Seeing our team the customers fled away from the spot. But we detained the above noted person along with one sky blue colour bag. On being asked the above noted accused person disclosed his name and address as noted above and also disclosed that he was possessing cough Syrup and some Drugs tablets inside the said bag, which he obtained the same fraudulently for selling his designed customer in high price. Then I called two disinterested witnesses namely (a) Malin Ch. Roy(26),s/o Manoranjan Roy of Dakhin

Palash, Natun Bazar, PS- Bhaktinagar, Dist.-Jalpaiguri and (b) Lab Roy(30), s/o Lt. Kalata Roy of Prokashnagar, Chiarujhote, w/n-42, PS-Bhaktinagar Dist.-Jalpaiguri. In presence of the cited witnesses search was conducted and above noted cough Syrup and tablets were recovered from his possession and all the above noted articles have been seized and labeled in presence of above noted cited witnesses under proper seizure list and duly signed by the accused person as well as witnesses and took into custody as alamp property. The seizure was made in between 21:40 hrs to 22:15 hrs. On interrogation and demand the accused person failed to produce any valid document or any valid licenses in support of their possession such huge quantity of drugs. The accused Pankaj Sharma (38) S/O- Dinesh Sharma of Shantikunj near Mansha singh Compound, Ward No- 41, Sevoke road near Don Bosco More PS- Bhaktinagar Dist- Jalpaiguri also confessed that he has been running this illegal business of Drugs at his Medicine Shop defying law enforcing administration publicly by selling Drugs. He obtained the consignment of cough syrup and Tablets from somewhere in Siliguri area fraudulently with a view to sell the same to drug addicted people and students of colleges and schools of under Bhaktinagar PS, Dist-Jalpaiguri places. Hence I took him into custody after observing all the guidelines of Honorable Apex Court regarding arrest.

During preliminary enquiry, it could be learnt that the above noted arrested accused procures contraband drugs from people who commits theft in respect of such drugs or obtains fraudulently, without any valid paper in lower price and clandestinely dispose the same to designed usual addicts, those who purchase contraband drugs from his shop.

Under the circumstances the above noted accused violated section of Drugs and Cosmetic Act 1940.


Hence it is prayed that a specific case may kindly be started against the accused namely Pankaj Sharma (38) S/O- Dinesh Sharma of Shantikunj near Mansha singh Compound, Ward No- 41, Sevoke road near Don Bosco More PS- Bhaktinagar Dist- Jalpaiguri and arrange for its investigation.
