Sir,

In producing herewith one arrested accused person namely Asharu Roy-45yrs s/o Lt Dhananjay Roy of Tarijote, Balasan colony, PS Matigara Dist Darjeeling along with seized articles viz:- One loaded Truck bearing plate no-WB71/0315 loaded with River Bed materials, Sands.

I ASI Niranjan Sarkar of Khalpara TOP under Siliguri Police station lodge a written complaint against the above noted person to the effect that today i.e. 06.06.21 at about 09.00 hrs while performing my TOP mobile van duty and reached at Jhankar More under Siliguri PS found that one Truck bearing Registration No. WB71/0315 loaded with illegal River Bed Material, sands was coming from Balasan colony, Matigara side and going towards Burdhaman road. Myself along with force apprehended one Truck bearing Registration No. WB71/0315 along with its driver and on checking the vehicle and found the truck loaded with Sands. On demand, the driver of the Truck disclosed his name and identity as noted above. Further, on demand the driver of the truck failed to produce any valid documents related to the Truck as well as the loaded River Bed materials, Sands in the Truck. Hence there was reason to believe that the driver of the Truck had procured the vehicle along with its loaded material illegally and transporting the same for his illegal gain.

On further grilling he discloses that he along with the owner of the Truck in association with others of Balasan River Ghats had procured the river bed materials, Sands illegally from and carrying/transporting the same to Siliguri side for their wrongful gain without any valid documents..

Under the circumstances, I seized the Truck bearing Registration No- WB71/0315 along with loaded sands under proper seizure list and arrested the driver of the Truck under proper Memo of Arrest after explaining the reason of arrest to him. The whole process of search, seizure and arrest took place in between 09.30hrs to 10.20hrs.

Under the above, I pray before your kind end to start a case against the above arrested person namely Asharu Roy-45yrs s/o Lt Dhananjay Roy of Tarijote, Balasan colony, PS Matigara Dist Darjeeling and the owner of the seize vehicle under proper section of law and caused its investigation.
