In producing here with 09 (Nine) arrested accused persons who disclosed their identity as (i) Sandip Roy (21) S/O Khebru Roy of D.S Colony Ward No 34 PS- NJP Dist- Jalpaiguri. (ii) Amar Hari (32) S/O Santosh Hari of DO, (iii) Pradip Barman (32) S/O Khirod Barman of Haripur Nichpara Near Kalimandir PS- NJP Dist- Jalpaiguri, iv) Sourav Ghosh (24) S/O Tapan Ghosh of Mahanandapara Chandrapark Ward No 04 PS- Siliguri Dist- Darjeeling. (v) Panchu Ghosh (32) S/O Anil Ghosh of Suryasen Colony Block D Ward No 24 PS- NJP Dist- Jalpaiguri.(vi) Rabin Das (34) S/O Munna Das of Santoshinagar Near Santoshi Mandir Ward No 05 PS- Siliguri Dist- Darjeeling (vii) Bapan Dutta (24) S/O Krishna Dutta of Kamrangaguri Near Uttar Kanya PS- NJP Dist- Jalpaiguri. I, SI. Susanta Das of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that on 06-06-21 at 16.15 hrs, myself along with SI. Md Shajahan Ali, ASI Md. Jinnat Ali, ASI Sanjoy Hasda and force while performing Special mobile van duty at Jhankar More , Siliguri area, Vide Khalpara TOP-II, GDE No-178/21 dated 06.06.21 and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, and Order No-647-ISS/2M-22/2020 DATED 15-05-21. wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19 .. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security and as per order of I/C Siliguri P.S, and O/C Khalpara TOP-II, I released the above noted accused persons after obtaining bail bond & P.R Bond.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
