Sir,

In producing herewith the arrested accused persons namely 1) Md. Halim (35) S/O Md. Gul Muhammad of Old Matigara Road, Gate Bazar, PS-Pradhannagar, Dist-Darjeeling, 2) Md. Naimuddin (45) S/O Md. Ful Muhammad of mallaguri, Near Hanuman Mandir, PS-Pradhannagar, Dist- Darjeeling, 3) Md. Afridi (18) S/O Md. Kalim of Old Matigara Road Gate Bazar, PS-Pradhanagar Dist-Darjeeling, 4) Anrit Kharia (25) S/O Birram Kharia of Sukna T.E. Line No.18 PS-Pradhannagar, Dist-Darjeeling arrested U/S 41 Cr. P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 07.06.2021 while performing special van duty vide GDE NO. 326 Dated 07.06.2021 at around 18:00 hrs I found that the above noted persons had come out of their house without any specific purpose and moving freely on Siliguri Junction area. I shared the information with you and as per your kind direction, I along with force brought the persons under arrest as they had violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No -436-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. On interrogation, they all disclosed their names and address as noted above. On further grilling, all of them admitted that they all were aware of th Lockdown Order and restrictions imposed upon the movement of human being and they had been moving without any specific reason. As they had violated the order of lockdown promulgated by the appropriate authority and also the provisions of Disaster Management Act, 2005, I with the help of force arrested them U/S 41 Cr. P.C preparing proper memo of arrest.

I, therefore, pray before you that a specific case may kindly be started against above noted persons and take lawful action.
