Sir,

In producing herewith four arrested accused persons namely (1) Tapas Barman-29yrs s/o Kalachand Barman shiv mandir, PS Matigara, Dist Darjeeling (ii) Raju Mangar-29yrs of Checkpost Kalua colony PS Banarhat Dist Jalpaiguri (iii) Chandan Roy-28yrs s/o Krishna Roy of Kawakhali , Near NBMC & (H) PS Matigara Dist Darjeeling and (iv) Bidhan Roy -30yrs s/o Sushil Roy of Rana nagar colony, PS Matigara Dist Darjeeling along with seized articles viz:-

(1) One loaded Truck bearing plate no-NL01N/4648 loaded with River Bed materials, Sands (2) One loaded Truck bearing plate no-WB73E/8209 loaded with River Bed materials, Sands. (3) One loaded Truck bearing plate no-WB73F/0969 loaded with River Bed materials, Sands. (4) One loaded Truck bearing plate no-NL01Q/9132 loaded with River Bed materials, Sands.

I ASI Zinnat Ali of Khalpara TOP under Siliguri Police station lodge a written complaint against the above noted person to the effect that today i.e. 09.06.21 at about 04.30 hrs while performing my TOP night mobile van duty and reached at Jhankar More under Siliguri PS found that four Trucks loaded with illegal River Bed Material, sands was coming from Balasan colony, Matigara side and going towards Burdhaman road. Myself along with force apprehended those above noted Trucks along with its driver and on checking the vehicle and found the truck loaded with Sands. On demand, the drivers of the Trucks disclosed their name and identity as noted above. Further, on demand the drivers of the truck failed to produce any valid documents related to the Trucks as well as the loaded River Bed materials, Sands in the Truck. Hence there was reason to believe that the driver of the Trucks had procured the vehicle along with its loaded material illegally and transporting the same for his illegal gain after violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -**486-CS/2021 dated 24.04.21** arising out of order No- **79-CS/2020 dated 12.04.2020**, & order No-**629-1SS/2M-22/2020 dated 05.05.21** & Order No-**647-1SS/2M-22/2020 dated 15.05.21 that wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation** and to prevent spread of COVID-19. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country.

On further grilling they disclose that they along with the owner of the Trucks in association with others of Balasan River Ghats had procured the river bed materials, Sands illegally from and carrying/transporting the same to Siliguri side for their wrongful gain without any valid documents..

Under the circumstances, I seized the Trucks along with loaded sands under proper seizure list and arrested the drivers of the Truck under proper Memo of Arrest after explaining the reason of arrest to them. The whole process of search, seizure and arrest took place in between 04.40 hrs to 05.30hrs).

Under the above, I pray before your kind end to start a case against the above arrested person namely (I) Tapas Barman-29yrs s/o Kalachand Barman shiv mandir, PS Matigara, Dist Darjeeling (ii) Raju Mangar-29yrs of Checkpost Kalua colony PS Banarhat Dist Jalpaiguri (iii) Chandan Roy-28yrs s/o Krishna Roy of Kawakhali , Near NBMC & (H) PS Matigara Dist Darjeeling and (iv) Bidhan Roy -30yrs s/o Sushil Roy of Rana nagar colony, PS Matigara Dist Darjeeling and the owner of the seize vehicles under proper section of law and caused its investigation.
