In producing herewith six (06) arrested accused persons who disclosed their name & identity as (i) Rohit Mahato (20yrs) S/O- Rajkumar Mahato of Majumder Colony, Mahananda Para, Ward No-4, PS-Siliguri, Dist-Darjeeling, (ii) Dhananjay Singha (60yrs) S/O- Lt. Bhagabati Singha of Mallaguri, Satyajit Nagar Colony, Ward No-46, PS-Pradhannagar, Dist-Darjeeling, (iii) Bikash Das (30yrs) S/O- Lt. Subash Das of Ujjal Nagar, Ghorarbari, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Arun Kr Roy (60yrs) S/O- Lt. Abhay Roy of Gurung Busty, Manasa mandir Road, PS-Pradhannagar, Dist-Darjeeling, (v) Paban Roy (21yrs) S/O- Janaka Roy of Champasari, Dhaktikata, PS-Pradhannagar, Dist-Darjeeling, (vi) Kamona Paul (43yrs) S/O- Lt. Bhagirath Paul of Hyderpara, near Primary School, Ward No-39, PS-Bhaktinagar, Dist-Jalpaiguri, (vii) Manoj Gupta (44yrs) S/O- Kanhiya Prasad Gupta of Champasari Anchal, near Jatiya Sangha Club, Ward No-46, PS-Pradhannagar, Dist-Darjeeling, (viii) Sohed Ali (18yrs) S/O- Mujibur Rahaman of Gurung Busty, Birjawan Chalk, Ward No-03, PS-Pradhannagar, Dist-Darjeeling along with their vehicles bearing Nos viz- (i) Toto green colour without number, (ii) Toto red colour without number, (iii) Toto yellow colour bearing No. WB 73F/3700, (iv) Toto maroon colour without number, (v) Toto blue colour without number, (vi) Toto red colour without number, (vii) Toto blue colour without number & (viii) Toto green colour without number. I, SI Malay Kumar Roy of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 08.06.2021 at 10.45 hrs during my R/T Mobile Van duty had been to Venus More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Three of them namely Subash Roy, Animesh Das and Arbind Kr. Sha were roaming with their respective vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
