In producing herewith 09 (Nine) arrested persons who disclosed their identity as (i) Intekhab Alam- 59yrs s/o Md Alam of Vidyachakro colony, Near CPIM Party office PS Bhaktinagar Dist Jalpaiguri (ii) Shambhu Barman-46yrs s/o Jala Barman of Binay Krishna pally, Near Shib Mandir, PS Matigara Dist Darjeeling (iii) Gopal Debnath-42yrs s/o Sunil Debnath of Khoranijote Shiv Mandir PS Matigara Dist Darjeeling (iv) Bijay Biswas -25yrs s/o Bikash Biswas of Kawakhali Bazar Near Hari chand Mandir PS Matigara Dist Darjeeling (v) Ashim Biswas-45yrs s/o Lt Kalipada Biswas of Dabgram, Near Mahila college PS Siliguri, Dist Darjeeling (vi) Biren Karmakar-25yrs s/o Subal Karmakar of Fuleswari, Near Kali Mandir PS Siliguri Dist Darjeeling (vii) Sushil Mistiri-54yrs s/o Nekunja Mistri of Saradapally Ward No-37 PS Bhaktinagar Dist Jalpaiguri (viii) Bishu Singha-27yrs s/o Shankar Singha of Diesel colony, Kolaiboktari PS Matigara Dist Darjeeling (ix) Dipak Dey-35yrs s/o China Kumar Dey of Binoy More, Shantinagar PS Bhaktinagar Dist Jalpaiguri along with all connecting papers.

I, SI Srimanta Chatterjee of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on performing Special mobile van duty against COVID-19 rules & guidelines. Myself along with ASI Aminul Islam, ASI Kalachand Singha and force all of Khalpara TOP-II under Siliguri PS had been to Jhankar More, Siliguri at about 16.45 hrs (Khalpara TOP GDE No- 274 dated 09.06.21) and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, & order No-629-1SS/2M-22/2020 dated 05.05.21 & Order No-

647-1SS/2M-22/2020 dated 15.05.21 that wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break-out of Pandemic COVID-19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons namely (i) Intekhab Alam- 59yrs s/o Md Alam of Vidyachakro colony, Near CPIM Party office PS Bhaktinagar Dist Jalpaiguri (ii) Shambhu Barman-46yrs s/o Jala Barman of Binay Krishna pally, Near Shib Mandir, PS Matigara Dist Darjeeling (iii) Gopal Debnath-42yrs s/o Sunil Debnath of Khoranijote Shiv Mandir PS Matigara Dist Darjeeling (iv) Bijay Biswas -25yrs s/o Bikash Biswas of Kawakhali Bazar Near Hari chand Mandir PS Matigara Dist Darjeeling (v) Ashim Biswas-45yrs s/o Lt Kalipada Biswas of Dabgram, Near Mahila college PS Siliguri, Dist Darjeeling (vi) Biren Karmakar-25yrs s/o Subal Karmakar of Fuleswari, Near Kali Mandir PS Siliguri Dist Darjeeling (vii) Sushil Mistiri-54yrs s/o Nekunja Mistri of Saradapally Ward No-37 PS Bhaktinagar Dist Jalpaiguri (viii) Bishu Singha-27yrs s/o Shankar Singha of Diesel colony, Kolaiboktari PS Matigara Dist Darjeeling (ix) Dipak Dey-35yrs s/o China Kumar Dey of Binoy More, Shantinagar PS Bhaktinagar Dist Jalpaiguri and arranged proper investigation of the case.
