Sir,

In producing herewith the one accused person namely Md. Raja Hashmi (22), S/O- Munna Hashmi of Gurung busty, Opposite TMC office, W/No-3, P.S.- Pradhan nagar, Dist- Darjeeling and the following seized articles:- (i) 36 (thirty six) bottles of RENDRYL Cough Syrup, marked as Exhibit-A, (Batch No 060520-MB10) (ii) 01(one) bottles of RENDRYL Cough Syrup taken from Exhibit-A for examination and marked as Exhibit-A-1 (iii) 13 (thirteen) bottles of RENDRYL NEO Cough Syrup, marked as Exhibit-B, (Batch NO 010720-MB11), (iv) 01(one) bottle RENDRYL NEO Cough Syrup taken from Exhibit-B for examination and marked as Exhibit-B-1, (v) 72 (seventy tow) strips of SIMPLEX C+ Capsules, containing each strips 08 capsules and marked as Exhibit-C, (Total capsules 576) (Batch NO SMC-19098), (vi) 01(one) strips of SIMPLEX C+ Capsule, containing 08 capsules randomly taken from Exhibit-C for examination and marked as Exhibit-C-1, vii) One big size Nylon bag in which the above noted articles was kept, viii) One blue colour Honda Activa Scooty bearing Reg. No WB74AQ-2301 in which the seized articles was carried by the above noted accused person.

I, ASI Ratan Pradhan of Pradhannagar P.S., SPC do hereby lodge the complaint to the effect that on 09.06.2021 at 22.10 hrs received secret source information vide PDN P.S. GDE NO 480, Dated 09.06.2021, that one person was standing beside Debidanga main road, in front of Sriguru School with a blue color scooty carrying huge quantity of drugs illegally for selling the same at Champasari area. I accordingly shared the information with you and as per your kind direction at 22.17 hrs myself along with ASI Debasis Das, ASI Ashit Singha, CV 131 Ranjan Sharma, CV 128 Ajay Kr Sahani, CV 992 Jagadish Biswas took departure for Debidanga main road, vide PDN P.S. GDE NO 483, MCC No 1487, Dated 09.06.2021. We reached at the spot at 22.25 hrs and cordoned the area and tried to call independent witnesses to present in the operation, but due to lockdown none could be found. Accordingly, after being confirmed by source apprehended the accused person with one blue colour Scooty which carrying a big size nylon bag. After disclosing our identity he also disclosed his identity as Md Raja Hashmi (22). Accordingly, I searched the apprehended person. On searching the big size nylon bag from the possession of the apprehended accused persons and recovered (i) 36 (thirty six) bottles of RENDRYL Cough Syrup, marked as (Batch No 060520-MB10) (ii) 13 (thirteen) bottles of RENDRYL NEO Cough Syrup, marked as , (Batch NO 010720-MB11), (iii) 72 (seventy tow) strips of SIMPLEX C+ Capsules, containing each strips 08 capsules and marked as (Total capsules 576) (Batch NO SMC-19098), (iv) One big size Nylon bag v) One blue colour Honda Activa Scooty bearing Reg. No WB74AQ-2301 in which the seized articles was carried by him in the nylon bag. On demand the apprehended person failed to produce any document in respect of the recovered drugs or in respect of the vehicle. Accordingly, I seized the above noted articles under proper seizure list. The seizure has made between 22.40 hrs to 23.25 hrs. Accordingly, at 23.30 hrs I arrested the accused person namely Md Raja Hashmi (22), S/O- Munna Hashmi of Gurung busty Opposite TMC office, W/No-3, P.S. - Pradhan nagar, Dist- Darjeeling, issuing proper memo of arrest. At 23.40 hrs myself along with other offers and force and seized article brought to Pradhan nagar Police station.

Hence, it is prayed that a specific case may kindly be started against the accused person namely Md Raja Hashmi (22), S/O- Munna Hashmi of Gurung busty, Opposite TMC office, W/No-3, P.S.- Pradhan nagar, Dist- Darjeeling, as per law.
