Sir,

I, Smt. Anjana Shil Singhania, Wife of Sri Manoj Kumar and Daughter of Sri Sudhir Ranjan Shil, presently residing at Vill. & P.O. Ranidanga, P.S. Bagdogra, Dist. Darjeeling, begs to lodge this written complaint against my husband (1) Sri Manoj Kumar, Son of Sri Buddha Ram, (2) Sri Buddha Ram (father-in-law), Son of not known, (3) Smt. Jaymanti Devi (mother-in-law), Wife of Sri Buddha Ram, (4) Sri Binod Kumar (brother-in-law), Son of Sri Buddha Ram, (5) Smt. Minu, Wife of Sri Binod Kumar, (sister-in-law), (6) Smt. Anita Devi, D/o Sri Buddha Ram, (7) Guddi, D/o Sri Buddha Ram (8) Smt. Punam Devi, Wife of Sri Kuldeep, (9) Sri Kuldeep (husband of Punam Devi), all are residing at Vill. Sahriya Jawahar, P.O. Tanda, Tahsil – Tanda, Rampur, Dist. Uttar Pradesh – 244925.

Sir, I have been married according to Hindu rites and customs on 01.08.2013 with the Accused Person No.1 Sri Manoj Kumar at Siddeshwari Kali Mandir, S.F. Road, Siliguri, Dist. Darjeeling.

That my husband is working as a SI Steno, S.S.B. and at the time of marriage he was posted at Falakata Area Office and after marriage I went to my husband work place at Falakata in a rented house since 3½ years.

From the very beginning of my marriage my husband and in-laws started to rebuking me on some petty issues and they also assaulted me by saying that "you are coming from low standard family and my in-laws over telephone told that your father has not spend anything in your marriage". In spite of that I bear all inhuman torture for the sake of our happily married life.

In the year 2016 my husband transferred at Dirang, Arunachal Pradesh and from that period I was residing my father's house at Ranidanga, Bagdogra, Dist. Darjeeling and my husband often come to my father's house when he came Siliguri. Out of the aforesaid wedlock on 23.04.2018 a male child was born named Abhay Kumar Singhania. After that my husband Accused Person No.1 changed his behaviour and he refused to provide food and medicine to me and our minor child and he did not communicate with me regularly. When I asked my in-laws for the illegal behaviour of my husband then my in-laws also threatened me that you are not our choice and they give the Accused Person No.1's marriage to another lady. That on March, 2020 Accused Person No.1 came to his parental house at Vill. Sahriya Jawahar, P.O. Tanda, Tahsil - Tanda, Rampur, Dist. Uttar Pradesh and then he came to my father's house at Ranidanga only for one day, then I noticed that the behaviour of the Accused Person No.1 was completely changed and he tried to avoid me in each and every moment and when I have made protest against his behaviour then he assaulted me by using filthy languages and also threatened me that he will not take the responsibility of me and our son.

That on 16.04.2021 it came to my knowledge that my husband going to marry with another lady named Anshu Kumari and it also came to my

knowledge that on 1st October, 2020 my husband Accused Person No.1 arranged engagement ceremony with Anshu Kumari at his residence at Vill. Sahriya Jawahar, P.O. Tanda, Tahsil – Tanda, Rampur, Dist. Uttar Pradesh. After knowing that on 16.04.2021, I informed that matter to Inspector General, S.S.B., Bhilai, Chhatisgarh.

Be it mentioned here that from last 1 (one) year Accused Person No.1 stopped all communication with me and he blocked my mobile phone number in his all contacts and Accused Person No.1 did not provide any sort of maintenance in favour of me and my minor son. After that I tried to communicate with my in-laws's house over telephone then the accused persons threatened me that if I want to go to my matrimonial house at Vill. Sahriya Jawahar, P.O. Tanda, Tahsil – Tanda, Rampur, Dist. Uttar Pradesh then they will kill me and my minor son. Due to the accused persons torture I have alongwith my minor son have no way to survive and if the Accused Person No.1 do not provide us food and medicine then I alongwith my minor son came on pavement. Finding no other alternative I came before you for your help and support.

In view of the above facts and circumstances I would request you to take immediate steps against (1) Manoj Kumar, (2) Sri Buddha Ram, (3) Smt. Jaymanti Devi, (4) Sri Binod Kumar, (5) Smt. Minu, (6) Smt. Anita Devi, (7) Guddi, (8) Smt. Punam Devi, (9) Sri Kuldeep as per law and oblige.
