Bhaktinagar, Dist- Jalpaiguri would like to lodge this written complaint to the effect that, I reside at the above mentioned address with my wife and two children very peacefully since very long at my father's land. My matrimonial life runs smoothly until the interference caused by my in-law relatives. My Sister-in-law and her husband namely Urmila Mallick and her husband Ranjit Mallick who are the residents of Harekrishna Pally, Lower Bagdogra, District- Darjeeling and my brother in-law namely Suresh Mallick, Pradip Mallick, Dipu Mallik and Bicky Mallick who are residing at near Dhuliya More Bridge, Belgachi Tea Estate within Maniram Gram Panchayat, P.O. & P.S. Naxalbari, District-Darjeeling, always interfere in my matrimonial house and mislead my wife as a result my wife picks up quarrels without any just and cause reason as per the instigation of my in-laws. That my wife always remains busy in talking with her relatives and the other neighbors and do not pay any attention to the matrimonial household works. That on 17/05/2021 a hot conversation was going on between me and

my wife as she did not prepare food for my children and she remained busy with talking to a neighbor and on the same day above mentioned Urmila Mallick, Ranjit Mallick, Suresh Mallick, Pradip Mallick, Dipu Mallik and Bicky Mallick entered at my bedroom and locked my room from inside and without any cause and reason they started to assault me by fists, kicks and blows and all other members/wrongdoers hold me from back side and Pradip Mallik was continuously assaulting me by fists and kicks on my nose, ear stomach and they tried to strangle me by pressing my throat and my nose and ear was continuously bleeding enough and my T-shirt was smear of blood and not only this the above mentioned Pradip Mallik tried to kill me with the help of pillow which was kept in my bedroom but somehow I manage to open the gate locked by them and neighbors reached at my house and rescued me and my daughter namely Renu Basfore call my brother and disclose that her maternal relatives are assaulting me very badly and when my father and brothers came the wrongdoers attacked on my brother Dinesh Basfore who is an undergoing Tuberculosis(TB) patient and he also sustain injuries on his personnel and thereafter my cousin brother took me to Siliguri District Hospital and where the Doctors started my treatment but they were unable to provide me bed due to present

Pendamic Covid situation and referred me to ENT expert and also prescribed me bed rest for at least 10 days.

I was remain busy in my treatment and as a result I could not lodge the written complaint in due time and some delay has been caused.

I, therefore, request you to register this complaint as FIR and please take necessary legal steps against said accused persons and as per the provisions of law and obliged thereby.
