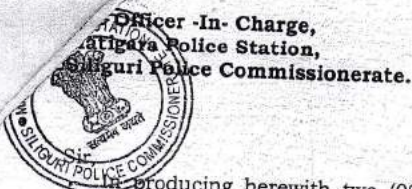

producing herewith two (02) lady accused namely (i) Pinki Debi(28), W/O-Ajay Mahato of Radhanagar, Garhbanaili, PS- Kasba, Dist- purnia, State- Bihar and (ii) Jilabia Debi (42), W/O-Ramdaras Yadav of Vidya Nagar, PO+PS+Dist-Katihar, State-Bihar under arrest along with following articles under proper seizure;

1. 40 (forty) bottles of 'RHINO GOLD' Premium Whisky (each bottle containing 750 ml @ Rs 250/- each bottle Total value Rs- 10,000/-) kept in a brown colour travel bag styled as "SS SEA STAR" and marked as "Exhibit-A" out of which 01 (One) bottle taken as sample and marked as "Exhibit -A-1" [The article was found under exclusive and conscious possession of lady accused Pinki Debi.
2. 40 (forty) bottles of 'RHINO GOLD' Premium Whisky (each bottle containing 750 ml @ Rs 250/- each bottle Total value Rs- 10,000/-) kept in a Blue and Red colour travel bag styled as "PUMA" and marked as "Exhibit-B" out of which 01 (One) bottle taken as sample and marked as "Exhibit -B-1" [The article was found under exclusive and conscious possession of lady accused Jilabia Debi.

I, SI Shekhar Adhikary of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted (i) Pinki Debi(28), W/O-Ajay Mahato of Radhanagar, Garhbanaili, PS- Kasba, Dist- purnia, State- Bihar and (ii) Jilabia Debi (42), W/O-Ramdaras Yadav of Vidya Nagar, PO+PS+Dist-Katihar, State-Bihar to the effect that today on 11.06.2021 at about 05.45 hrs received a source information that two lady are standing at Shivmandir Medical More with huge quantity of liquor under their possession without any valid license with a view to transport the same to Bihar through Bihar bound vehicle. Accordingly the fact was diarized vide Matigara PS GDE No- 442 Dt. 11.06.2021 and shared the information with O/C Matigara PS and subsequently, as per his kind direction myself along with CV-155 Sukumar Das, C/986 Rajib Sarkar, C/1035 Santosh Robidas and LC/1251 Yankila Bhutia had been to Shivmandir Medical More vide Matigara PS C.C No- 1401/2021 Dt. 11.06.2021 to verify the veracity of the information. On reaching at Shivmandir Medical More at 06.05 hrs and being pointed by my reliable source, we apprehended two ladies and from their exclusive and conscious possession the above note articles could be found of which they failed to produce any valid documents. Subsequently, being interrogated, both the apprehended lady after disclosing their identity as above further revealed that they have procured the above noted whisky clandestinely for transporting and selling the same to Bihar to their designed customer at high rate for their wrongful gain and they don't have any valid license for the same. Accordingly, I seized and labeled the above mentioned articles at the spot under proper seizure list in presence of witnesses and also arrested the above mentioned lady namely Pinki Debi(28), W/O-Ajay Mahato and Jilabia Debi (42), W/O-Ramdaras Yadav with the help of accompanied lady constable observing all sorts of formalities. The whole process of seizure has been made in between 06.25 hrs to 07.05 hrs at the spot.

Therefore, I pray before your good self that a specific case may kindly be initiated against (i) Pinki Debi(28), W/O-Ajay Mahato of Radhanagar, Garhbanaili, PS- Kasba, Dist- purnia, State- Bihar and (ii) Jilabia Debi (42), W/O-Ramdaras Yadav of Vidya Nagar, PO+PS+Dist-Katihar, State-Bihar under proper section of law and arrange for its investigation.
