In producing herewith one arrested accused person namely i) Laxman Yadav 46yrs s/o Radhashyam Yadav Vill: Rampur PO, Gourgram PS, Amarapur Dist, Baka State Bihar along with the seized two Vehicle out of one front side RC No displayed BR11S/4113 and back side RC No displayed BR11T/4113 Twelve wheeler empty Truck driver of said vehicle and another bearing ten wheeler truck bearing RC No WB78/5291 driver of the vehicle is managed to escape to left his vehicle.


I beg to submit that today ie on 11.06.2021 at 18.10 hrs received a secret reliable source information that two nos of truck parked in front of Tirupati Petrol Pump Gosainpur More beside AH-02 also stated that he suspect the both vehicles sufficient reason to believe stolen away by their driver. Accordingly, I informed the mater to OC Bagdogra Ps, and as per his kind direction, I along with force rushed the spot ie Gosainpur in front of City Dhaba to verify the veracity of information vide GDE No. 554 dtd 11.06.2021. At about 18.25 hrs we reached at Gossainpur More in front of Tirupati Petrol Pump source shown both the vehicle we intercepted and found that the mentioned Vehicle parked in front of Tirupati Petrol Pump seeing the presence of police, driver of vehicle bearing RC No WB78/5291 managed to escape to left his vehicle. We apprehended driver of vehicle RC No BR11S/4113 @ BR11T/4113. On demand, said Laxman Yadav driver of Vehicle No. BR11S/4113 @ BR11T/4113 failed to produce any valid documents in support of him or vehicle. On interrogation he confessed that one person identity not known residing at Purnia asked him to sell out the said vehicle in the State of Assam to his designated customers but he did not produce any valid documents on the vehicles. So, there is sufficient ground to believe that the above noted seized vehicles either theft or any other fraudulent means and for which. Hence, I seized the both Vehicles out of one front side RC No displayed in BR11S/4113 and back side RC No displayed in BR11T/4113 Twelve wheeler empty Truck and another ten wheeler truck bearing RC No WB78/5291 under proper seizure list maintaining all formalities, the seizure process was made in between 18.45 hrs to 19.50 hrs and subsequently arrested the said accused person Laxman Yadav observing all formalities and narrated him the ground of his arrest. On interrogation, he unable to give any satisfied reply on demand he also failed to produce any documents of the vehicle.

Under the above circumstances, I pray to your honour that a specific case under proper section of law may kindly be registered against accused Laxman Yadav 46yrs s/o Radhashyam Yadav Vill: Rampur PO, Gourgram PS, Amarapur Dist, Baka State Bihar the driver of Vehicle No. RJ02GC-1286 and arrange for its investigation.


