In producing herewith five (05) arrested accused persons who disclosed their name & identity as (i) Nabin Sutradhar (50yrs) S/O- Lt. Biswanath Sutradhar of Noukaghat, near Mixture Mill, PS-NJP, Dist-Jalpaiguri, (ii) Rakhal Mandal (48yrs) S/O- Lt. Nidhiram Mandal of Purba Chayanpara, near Ashighar more, PS-Bhaktinagar, Dist-Jalpaiguri, (iii) Sukumar Malakar (32yrs) S/O- Narayan Malakar of Kawakhali, near Netajimore, PS-Matigara, Dist-Darjeeling, (iv) Dipak Roy (23yrs) S/O- Swapan Roy of Tikiapara, Ambedkar Colony, PS-Siliguri, Dist-Darjeeling & (v) Md. Shamsar (32yrs) S/O- Md. Karamullah of Koila Depot, Khalpara, PS-Siliguri, Dist-Darjeeling along with their vehicles viz- (i) Toto green colour without number, (ii) Toto sky colour without number, (iii) Toto white/green without number, (iv) Toto red colour bearing No. WB 73TC/0409 & (v) Toto maroon colour without number. I, SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 10.06.2021 at 17.50 hrs during my R/T Mobile Van duty had been to S.F Road Thana More area, Siliguri and found the above noted persons were gathered/roaming without wearing mask on their face and without any proper reasons with their respective vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
