That the said truck was loaded from Bikkampur Tannery (P) LTD situated at Debgram industrial Growth Centre WBIIDC Jalpaiguri - 734015 West Bengal. The truck was loaded with 947 (Nine hundred forty seven) bags of teas valued at Rs. 42,86,045/- (Rupees Forty two lakhs eighty six thousand forty five only) approx. for carrying/transporting the same to Dadanagar, Kanpur, Uttar Pradesh. The truck started its journey on 03.06.2021 and was driven by the above named driver who assured me that the following bags of teas shall be delivered within 07.06.2021.

But unfortunately as the said truck did not reach the destination within 07.06.2021, we tried to communicate with the driver by our all means but his mobile was continuously switched off. As per the toll receipt shared by the truck owner the vehicle last crossed at Maithi toll tax (Bihar) on 05.06.2021 at 02:14 AM (approx 25 km from Muzaffarpur Bihar). After that we did not get any information of the vehicle.

Therefore, I request you to accept this complain and lodge the First Information Report in the name of Mr. Ujjawal Singh (Owner of the Truck) and MR. Shivshankar Yadav (Driver of the Truck) and Kanpur Banaras Roadlines (Lorry supplier).
