Sir,

With due respect, I am producing herewith the arrested accused person namely Kamal Roy S/O Jiten Roy Ghorarbari, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 11 (Eleven) bottles of 60 up Himalayan Gold Country Spirit containing 600 ML in each bottle of Rs 100/- of each bottle.
2. 22 (Twenty two) bottle of 60 up Royal Choice Country Spirit containing 300 ml in each bottle of MRP RS 50/ of each bottle.
3. 08 (eight) bottles of TUBOGR premium Beer containing 650 MI in each bottle of MRP Rs 160/- of each bottle.

I beg to state that today i.e. on 11.06.21 at 00.05 hrs I received a secret source information that one person named Kamal Roy of Ghorarbari is selling ID liquor at his residence at Ghorarbari for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 480 dated 11.06.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava and CV/824 Niru Kr Yadav All of NJP PS, SPC left for Ghorar Bari to work out the information in hand. At about 00.35 hrs we arrived at Ghorarbari and being shown and identified by the source we held raid at the house of accused Kamal Roy and managed to intercepted him. During interrogation he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Kamal Roy S/O Jiten Roy Ghorarbari, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 00.45 hrs to 01.15 hrs on 11.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Kamal Roy S/O Jiten Roy Ghorarbari, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
