Respected Sir,

This is to inform you that SANTU BISWAS, aged 36 years, of Netaji Subhas Road, Bhaktinagar, Siliguri, Dist.- Jalpaiguri, West Bengal-734007, has been working in this organisation as pump manager since last 2 (two) years. The name of the petrol pump is P&G Kishan Seva Kendra, which is situated in Sindoomuchi, P.O.- Dehaband, P.S.- Kushmundi, Dist.- Dakshin Dinajpur, pin- 733132. After reconciliation of our internal audit on 20-04-2021, it has been found that there was shortage of Rs. 4,70,000/ (Rupees four lacs seventy thousand) only. Santu Biswas, the Manager agreed about the misconduct of money and he prayed apology. He also made an agreement towards the management where he committed to pay the amount of Rs.4,70,000/ (Rupees four lakhs seventy thousand) only within a period of one year.

After his prolonged request and prayer the Management being sympatnetic to him and depute him in the same post and in the same pump.

Today afternoon he has come to our pump, named Bagdogra Auto Supply, Bagdogra Biharmore, Surya Nagar, Dist.- Darjeeling, pin- 734014, West Bengal, to deposit a amount of Rs. 68507/ (Rupees sixty eight thousand five hundred and seven) only and I received the amount being the manager of Bagdogra Auto Supply as per our HO's instruction but when I went to the toilet all of a sudden he took the amount and tried to flew away. We the staff of Bagdogra Auto Supply caught him and keep him in our pump.

Now, Sir you are requested to do the needful legal action.
