Respected Sir,

I, Ajima Khatoon Sutradhar, Wife of Ravi Sutradhar, resident of Pabitra Nagar, Near Himkshosh Bhawan, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, would like to inform you the following facts:-

- 1) That my marriage was solemnized with Ravi Shankar Sutradhar, Son of Gopal Chandra Sutradhar 3 (three) years ago and I have one 1½ years male child.
- 2) That soon after the birth of my child my husband and his all relatives started torture upon me they used me to do all the household work whole day, they did not allow me to take rest even for 10 (ten) minutes in a day, they used to abuse me with filthy languages and did not provide me to take food properly even I am not allowed to talk to anyone in our neighbours.
- 3) That on several occasion my father gave cash Rs.30,000/- and Rs.50,000/- to my in-laws on their demand, so that they may not inflict torture upon me.
- 4) That on 28.05.2021 my husband and my in-laws drove me out after assaulting me mercilessly finding no other alternative I was compelled to live in my father's house.

5) That today i.e. on 05.06.2021 at about 12:00 pm
in-laws are selling my "stridhan articles" I went there and when I
asked them why have they sold my articles at that time they became
furious and my father-in-law, Gopal Chandra Sutradhar, mother-in-
law Mamuni Sutradhar, sister-in-law namely Rekha Sutradhar and her
daughter Neha Sutradhar and another sister-in-law Puja Sutradhar
started abuse me and assault me and thereafter they forcefully
dragged me inside the room and locked the room from inside and
with intent to murder me pressed my mouth by pillow and started
strangulate me by my Odhini and also tore all my wearing apparels
but anyhow out of my strong will I freed myself and raised hue and
cry and para people gathered and saved me.

Due to their such assault I received severe injuries on my
person and on my neck because of strangulation and I was treated at
Siliguri District Hospital.

I, therefore, request you to kindly take necessary legal action against
the aforesaid culprits for the commission of the aforesaid offence by them
upon me.
