Sir,

With due respect, I am producing herewith the arrested accused person namely Ravi Gupta (19 yrs) S/O Ashok gupta of Mamata Para, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 07 (Seven) bottles of 60 up Himalayan Gold Country Spirit containing 650 ML in each bottle of Rs 100/- of each bottle.
2. 21 (Twenty one) bottle of 60 up Royal Choice Country Spirit containing 300 ml in each bottle of MRP RS 50/ of each bottle.
3. 12 (Twelve) bottles of KINGFISHER premium Larger Beer containing 330 ML in each bottle of MRP Rs 61/- of each bottle.

I beg to state that today i.e. on 11.06.21 at 19.15 hrs I received a secret source information that one person named Ravi Gupta of Mamatapara is selling ID liquor illegally at his residence at Mamatapara for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 526 dated 11.06.21 and informed the fact to you. As per your kind direction and instruction myself along with C/1053 Paresh Rava and VP/13 Jamirul Islam, VP/08 Laxman Roy & CV/306 Biswajit Roy All of NJP PS, SPC left for Mamata Para to work out the information in hand. At about 19.45 hrs we arrived at Mamata para and being shown and identified by the source we held raid at the house of accused Ravi Gupta and managed to intercepted him. During interrogation he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents in respect of the above noted I/D liquor. Accordingly, I seized the above noted I/D liquor from the possession of accused Ravi Gupta (19 yrs) S/O Ashok gupta of Mamata Para, PS- NJP, Dist.- Jalpaiguri under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.05 hrs to 20.35 hrs on 11.06.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ravi Gupta (19 yrs) S/O Ashok gupta of Mamata Para, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.


