Sir,

In producing herewith one accused person namely Gobinda Roy (25 yrs), s/o – Arjun Roy of 2 No Takimnari near Bazar, PO- Milanpally, PS- NJP, Dist - Jalpaiguri under arrest along with seized articles viz (i) 01 sealed bottle of Royal Stag Blended Whisky containing 180 ml. each (ii) 03 (three) bottles of Imperial Blue whisky containing 180 ml. each (iii) 05 (five) pouch of Officer Choice Delux whisky 180 ml each (iv) 10 (ten) sealed bottles of 60 up Country sprit containing 600 ml each and styled as "Boss" (v) 02 (two) sealed bottles Imperial Blue whisky containing 750 ml each. I ASI Dipak Singh of Milanpally OP under NJP PS/SPC do here by lodged a written complaint to the effect that today on 11/06/21 at 19:05 hrs acting on a tip-off source information myself along with ASI Biswajit Adhikari, C/- 1052 Dipak Das, C/-959 – Dijen Chandra Roy had been to 2 No Takimari near bazar under Milanpally OP boarding in a PS govt. Vehicle to work out the information that a huge number of country sprit are stocked in the shop of one Gobinda Roy (25 yrs), s/o – Arjun Roy of 2 No Takimnari near Bazar, PO- Milanpally, PS- NJP, Dist - Jalpaiguri without license to sale the same in local liquor selling dens. This refers to Milanpally OP GDE No-263, dt-11/06/21. On arrival at Takimari bazar at the shop of Gobinda Roy. I summoned two local witnesses to witness the raid and on being identified by the engaged source we held raid in the shop of Gobinda Roy and could recover the above noted huge amount of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. The entire articles were kept hidden under wooden khat of the shop. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused person and took into the custody. The seizure and label was made in between 20:25 hrs to 20:45 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Gobinda Roy (25 yrs), s/o – Arjun Roy of 2 No Takimnari near Bazar, PO- Milanpally, PS- NJP, Dist - Jalpaiguri
