Sir,

In producing herewith four (04) arrested accused persons names (1) Ramesh Rai (32) S/O- Man Bahadur Rai of 11 th Mile ,Kalimpong PS+Dist- Kalimpong (2) Suman Chettri (22) S/O- Late Govin Chettri of Paljer Stadium PS- Sadar Gangtak ,Sikkim (3) Arun Haldar(19) S/O- Buddhi Haldar of Purba Majhabari near Jaykanta Primary School PS- Bhaktinagar Dist- Jalpaiguri and (4) Biswajit Das (22) S/O- Rangalal Das of Ektiasal Khudiram Colony, PS- Bhaktinagar Dist- Jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles under proper seizure list viz.

- (i) One iron Haswua measuring 54 cm (approx) in length including wooden butt measuring 17 cm (approx) from the possession of Ramesh Rai which was kept concealed on his back side,
- (ii) One iron rod measuring 48 cm (approx) in length from the possession of Suman Chettri which was held by him on his left hand,
- (iii) One iron made chopper measuring 36 cm (approx) in length from the possession of Niranjn Das which was kept concealed on his back side,
- (iv) One iron rod measuring 42 cm (approx) in length from the possession of Gopi Das which was held by him on his right hand,

I, SI- Sibdhan Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons namely (1)Ramesh Rai (32) S/O- Man Bahadur Rai of 11 th Mile ,Kalimpong PS+Dist- Kalimpong (2) Suman Chettri (22) S/O- Late Govin Chettri of Paljer Stadium PS- Sadar Gangtak ,Sikkim (3) Arun Haldar(19) S/O- Buddhi Haldar of Purba Majhabari near Jaykanta Prymary School and (4) Biswajit Das S/O- Rangalal Das of Ektiasal Khudiram Colony PS- Bhaktinagar Dist- Jalpaiguri and others to the effect that today i.e., on 12.06.2021 at 01.05 hrs received a sources information that 8/10 youths have assembled behind Dumping ground under Bhaktinagar PS with deadly weapons and making preparation for committing dacoity at the Bhaktinagar P.S.area. Accordingly, I shared the information with I/C Bhaktinagar P.S, SMP and as per his kind direction diarized the fact vide Bhaktinagar P.S GDE No-695\* dated 12/06/2021 and consequently, I along with ASI Rabin Lama, ASI Biplab Kumar Das, CV- 619 Dharmendra Roy CV-14 Labanyamoy Barman left P.S at 01.15 hrs for Dumping ground to verify the veracity of information. At 01:35 hrs reaching near 'Dumping ground and keeping our vehicle there and proceeded towards 'Dumping ground on foot and being indicated by the source found from a considerable distance that a gang of eight/ten persons were assembled near 'Dumping ground' and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but we managed to apprehend four persons along with the above noted articles from their possession as mentioned above, whereas the rest accused persons managed to flee away from the spot.

On interrogation the apprehended accused person disclosed their identity as above and admitted that they had assembled there to commit dacoity in that area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused person. The whole seizure was made in between 02.25 hrs to 03.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them after informing the ground of their arrest.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further enquiry. During the course of interrogation it could be revealed from the arrested accused persons that some others were also with them, but they able to flee away from the spot during the raid.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Ramesh Rai (32) S/O- Man Bahadur Rai of 11<sup>th</sup> Mile, Kalimpong PS+Dist- Kalimpong (2) Suman Chettri (22) S/O- Late Govin Chettri of Paljer Stadium PS- Sadar Gangtak, Sikkim (3) Arun Haldar (19) S/O- Buddhi Haldar of Purba Majhabari near Jaykanta Prymary School PS- Bhaktinagar Dist- Jalpaiguri and (4) Biswajit Das (22) S/O- Rangalal Das of Ektiasal Khudiram Colony PS- Bhaktinagar Dist- Jalpaiguri and others and arrange for its investigation.
