Sir,

With due respect, I am producing herewith one arrested accused person namely; Kshitish Barman (60) S/O- Late Upen Barman of Shantipara, Salugara, PS- Bhaktinagar Dist - Jalpaiguri along with the following seized articles:

- i) One used yellow colour plastic sack containing Eight kgs three hundred grams (8.300 grms) said to be Ganja marked as Exhibit- "A" and
- ii) One Hundred grams (100 grs) of said to be Ganja taken as sample from Exhibit -A and marked as "A-1."

I, SI Sibdhan Karmakar S/O-Late Birendra Nath Karmakar of Bhaktinagar Police station under Siliguri Police Commissionerate do here by lodge this written complaint against Kshitish Barman (60) S/O- Late Upen Barman of Salugara Shantipara PS- Bhaktinagar Dist - Jalpaiguri to the effect that today on 12.06.2021 at 17:05 hrs received a specific input from source that a man is illegally possessing huge quantity of ganja, which was being sold from his house at Salugara Shantipara area to his design customers for his wrongful gain. As there was a reason to believe that a search warrant or authorization cannot be obtained, without affording opportunity for the concealment of evidence or facility for the escape of the offender, accordingly, I diarized the information vide Bhaktinagar PS GD Entry No.734 date 12/06/2021 and informed the fact to I/C Bhaktinagar PS in writing. As per his direction, at 17:05 hrs I along with ASI Rabin Lama, CV-619 Dharmendra Roy, CV-14 Labanayamoy Barman, CV-935 Biplab Roy and CV-614 Sumit Kumar Roy all of Bhaktinagar PS without making delay left for Salugara Shantipara by vehicle No WB 73D /9488 to verify the veracity of the information vide Bhaktinagar PS GDE No-734 date 12/06/2021 & CC No- 1346/2021 date 12/06/2021. At the time of departure from the Police Station, I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad, weighing machine and all necessary kits for investigation.

At 17:25 we arrived at Salugara Shantipara under Bhaktinagar P.S. and called upon two independent witnesses namely (i) Rahul Singh S/O- Mohan Singh of Kamlanagar, Salugara PS- Bhaktinagar Dist- Jalpaiguri and (2) Prokash Singh S/O- Krishna Singh of Champasari Kadamtala Nayabusty PS- Pradhannagar Dist- Darjeeling and informed about the information to them and on writing requested them to be present with us during search and seizure, if any. Then in presence of the above two witnesses and as identified by the source we cordoned the house and conducted raid. I along with my police team could apprehend and detained the above noted person with strong reason to believe that the said person illegally possessed ganja at his house. I disclosed my identity as Police Officer from Bhaktinagar PS and also disclosed the identity of accompanying officers and force and also informed him about the reason of raid. On interrogation, he disclosed his name and identity as noted above and admitted that he had been possessing Ganja illegally for selling the same to his design customers. I demanded him to produce the said Ganja. He produced above noted seized yellow plastic sack which as claimed by him was Ganja from underneath the bed. I along with my force could smell the smelt of Ganja emanating from the said plastic sack.

As per provision of law, I gave him option notice in writing that whether he wanted to be search in presence of Executive Magistrate or any Gazetted Officer and he agreed in writing that he has no objection if the search and seizure be made in presence of any Gazetted officer. At 17. 55 hrs, I, in writing requested Shri. Amaresh Singh, I.C. Bhaktinagar PS, SPC, Gazetted Officer to be present at Shantipara, Salugara in the house of detained persons for search and seizure, as Ganja could be found in the possession of accused person Kshitish Barman and sent the same by hand of CV/619 Dharmendra Roy. At 18.35 hrs Shri. Amaresh Singh, I.C. Bhaktinagar PS, SPC, Gazetted Officer arrived at the spot and disclosed his identity to detained accused persons as well as to witnesses. As per provision of law, I in presence of Gazetted Officer requested the witnesses to search the person of police personnel and nothing could be found except wearing apparel. In presence of Shri. Amaresh Singh, I.C. Bhaktinagar PS, SPC, Gazetted Officer and in presence of witnesses searched was conducted on the person of detained accused but found nothing except wearing apparel. Then, in presence and under supervision of Shri. Amaresh Singh, I.C. Bhaktinagar PS, SPC, Gazetted Officer, I opened and searched the plastic sack, which was produced by detained Kshitish Barman from underneath the bed, from which smell of Ganja was coming out and found ganja kept inside. I demanded him to produce any valid papers or documents for possessing the said Ganja but he could not produce, rather admitted that he had been possessing and selling Ganja illegally to local designed customers.

Accordingly, with the help weighing machine which we had taken with us, I weighed the plastic sack containing ganja inside and found Eight kgs four hundred grams (8300 grms). I took 100 (hundred) grams as sample and packed in an envelope and sealed the same and also sealed the mother packet containing 8.300 grms of Ganja. I prepared label and marked yellow colour plastic sack containing Eight kgs three hundred grams (8.300 grms) said to be Ganja marked as Exhibit- "A" and One Hundred grams (100 grms) of said to be Ganja taken as sample from Exhibit -A and marked as "A-1." Accordingly, I seized the above noted articles in presence of disinterested witnesses under proper seizure duly signed by the seizure witnesses and acknowledge by the accused by putting his signature. Whole process of search and seizure was conducted in presence and under supervision of Shri. Amaresh Singh, I.C. Bhaktinagar PS, SPC, Gazetted Officer. The seizure and labeling was done in between 19.15 hrs to 20.05 hrs.

Then, I arrested the above noted accused person Kshitish Barman (60) S/O- Late Upen Barman of Salugara Shantipara PS- Bhaktinagar Dist - Jalpaiguri after observing all formalities of arrest after disclosing the ground of arrest and issued necessary Memo of arrest, as he was found violating the terms and condition of Narcotic Drugs and Psychotropic Act, 1985 by possessing the ganja illegally without any valid authority & license.

On further interrogation, he admitted that he procured the said illegal ganja from Cooch Behar side for the purpose of selling the same at Salugara for his personal gain by illegal means. He also disclosed that he has been dealing in such business of procuring and selling the Ganja illegally since many days.

Under the above circumstances, I pray to you that specific case under proper section of law may kindly be started against the accused person Kshitish Barman (60) S/O- Late Upen Barman of Salugara Shantipara PS- Bhaktinagar Dist - Jalpaiguri and arrange for its investigation.
