In producing herewith 06 (six) accused persons namely (1) Biswanath Majhi (40) S/O Pulin Majhi of Bidhan Market, Ward No. 11, PS- Siliguri, Dist- Darjeeling (2) Ranjit Dutta (44) S/O Lt. Sunil Dutta of Adarshya Pally, Ward No. 10, PS- Siliguri, Dist- Darjeeling (3) Malay Chakraborty (28) S/O Manik Chakraborty of Adarshya Nagar, Ward No. 04, PS- Siliguri, Dist- Darjeeling (4) Gopal Sarkar (45) S/O Lt. Gurunandan Sarkar of Rasbihari Sarani, Hakimpara, Ward No. 16, PS- Siliguri, Dist- Darjeeling (5) Pradip Mahato (19) S/O Anil Mahato of Satyajit Nagar Colony, Tea Action Road, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling (6) Md. Taslim (45) S/O Md. Siraj of Jhankar More, Ward No. 07, PS- Siliguri, Dist- Darjeeling under arrest.

I, SI Ashim Kr. Das of Panitanki Town out Post, PS- Siliguri, SPC, do hereby lodge a written complaint against the above noted accused persons to the effect that on 11.06.2021 at about 12:15 hrs while performing mobile petrolling duty at Bidhan Market near Radha Gobinda Mandir area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Biswanath Majhi (40) S/O Pulin Majhi of Bidhan Market, Ward No. 11, PS- Siliguri, Dist- Darjeeling (2) Ranjit Dutta (44) S/O Lt. Sunil Dutta of Adarshya Pally, Ward No. 10, PS- Siliguri, Dist- Darjeeling (3) Malay Chakraborty (28) S/O Manik Chakraborty of Adarshya Nagar, Ward No. 04, PS- Siliguri, Dist- Darjeeling (4) Gopal Sarkar (45) S/O Lt. Gurunandan Sarkar of Rasbihari Sarani, Hakimpara, Ward No. 16, PS- Siliguri, Dist- Darjeeling (5) Pradip Mahato (19) S/O Anil Mahato of Satyajit Nagar Colony, Tea Action Road, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling (6) Md. Taslim (45) S/O Md. Siraj of Jhankar More, Ward No. 07, PS- Siliguri, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any disease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No. 647- ISS/2M-22/2020 dated 15.05.2021 The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Biswanath Majhi (40) S/O Pulin Majhi of Bidhan Market, Ward No. 11, PS- Siliguri, Dist- Darjeeling (2) Ranjit Dutta (44) S/O Lt. Sunil Dutta of Adarshya Pally, Ward No. 10, PS- Siliguri, Dist- Darjeeling (3) Malay Chakraborty (28) S/O Manik Chakraborty of Adarshya Nagar, Ward No. 04, PS- Siliguri, Dist- Darjeeling (4) Gopal Sarkar (45) S/O Lt. Gurunandan Sarkar of Rasbihari Sarani, Hakimpara, Ward No. 16, PS- Siliguri, Dist- Darjeeling (5) Pradip Mahato (19) S/O Anil Mahato of Satyajit Nagar Colony, Tea Action Road, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling (6) Md. Taslim (45) S/O Md. Siraj of Jhankar More, Ward No. 07, PS- Siliguri, Dist- Darjeeling arrange for its investigation.
