In producing herewith five (05) arrested accused persons who disclosed their name & identity as (i) Nil Kamal Adhikary (40 yrs) S/O- Rabindra Nath Adhikary of Baribhasa, near Ram Krishna Mini Market, PS-NJP, Dist-Japaiguri, (ii) Kartick Saha (25 yrs) Subal Saha of Paschim Bhaktinagar, near Radha Gobinda mandir, PS-NJP, Dist-Jalpaiguri, (iii) Santu Saha (36 yrs) S/O- Debendra Nath Saha of Sukantanagar Auto Stand, Ward No-38, PS-Bhaktinagar, Dist-Jalpaiguri, (iv) Tapan Chanda (48 yrs) S/O-Lt. Paresh Chanda of Subhash pally, near Netaji Boys High School, PS-Siliguri, Dist-Darjeeling and (v) Raj Thakur (29 yrs) S/O- Rajesh Thakur of Haiderpara, Shivrampally, Ward No-39, PS-Bhaktinagar, Dist-Jalpaiguri. I, SI Uttam Kumar Baghira of Siliguri PS/SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 11.06.2021 at 17.155 hrs during my R/T Mobile Van duty had been to Fuleswari area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.
