Sir,

In producing herewith one arrested accused person namely Diwash BK (Biswakarma) (Male/23) S/O-Kuber Biswakarma of Ghuguni More, Haidarpara, ward No. 40, PS-Bhaktinagar, Dist-Jalpaiguri along with seized articles (i) 17 (Seventeen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 01

I, ASI Gopesh Ch Barman of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 11/06/2021 at 19:45 hrs during Special raid duty I received secret source information that one person is carrying huge quantity of country spirit through Bidhan road, towards Haidarpara. Accordingly I informed the information to O.C Panitanki TOP and as per his direction I along with, SI Rana Brahma, C/233 Nagen Ch Barman, C/114 Naresh Hasda, left for PO to work out the information. On arrival at Bidhan Road near Auto Stand at 20.05 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 17 (Seventeen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed which was kept in a Nylon Bag. On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Haidarpara and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 17 (Seventeen) Bottles of 60 UP Country Spirit styled as Himalayan Gold with Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 20:15 hrs to 20:30 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1700/-

Hence, under the above circumstances I am submitting this written complaint against the above accused person namely Diwash BK (Biswakarma) (M/23) S/O-Kuber Biswakarma of Ghuguni More, Haidarpara, Ward No. 40, PS-Bhaktinagar, Dist-Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
