In producing herewith arrested accused person namely Sankar Biswas (23) S/O Satya Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri Dist-Darjeeling along with seized articles vize- i) 29 (twenty nine) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 29 x Rs 50/- =RS.1450/-) ii) 25 sealed pouches of Officer's Choice Deluxe Whiskey containing 180 ml each amounting of Rs. 140x25 = Rs.3500/- as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Sankar Biswas (23) S/O Satya Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri Dist-Darjeeling to the effect that on 14.06.21 at 21.35 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated at Sarbohara Colony under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 674 dated 11.06.21 and informed the fact to I/C Siliguri PS. As per his direction of I/C Siliguri PS, I along with C/1409 Ananta Roy C/369 Rasfiuddin Mia and CV/622 Ramanath Barman and left Sarbohara Colony under Siliguri PS vide Siliguri P.S GDE NO: 675 dated 11.06.21 to verify the veracity of the information. On reaching at 21.55 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching we found i) 29 (twenty nine) sealed bottles of Himalayan Gold 60 up country spirit containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 29 x Rs 50/- =RS.1450/-) ii) 25 sealed pouches of Officer's Choice Deluxe Whiskey containing 180 ml each

amounting of Rs. 140x25 = Rs.3500/- which was kept concealed in his house. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since last eight (08) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 22.05 hrs to 23.00 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested him U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Sankar Biswas (32) S/O Satya Biswas of Sarbohara Colony, Ward No. 28, PS- Siliguri Dist- Darjeeling under proper section of law and arrange for its investigate.
