Sir,

In producing herewith the following three (03) persons arrested namely 1) Ayaz Hussain @ Raj (26), S/O- Mehendi Hussain @ Metia of Gurung Busty, P.S.- Pradhan nagar, Dist- Darjeeling, 2) Manoj Mirdha @ Raja (23), S/O- Manoranjan Mirdha of Debidanga bazaar, P.S. Pradhan nagar, Dist- Darjeeling, 3) Bikram Saibo (30), S/O- Lt Anik Saibo of Debidanga, Sishabari, P.S. Pradhan nagar, Dist- Darjeeling, along with the following seized articles:-

- i) One iron country made Pistol, having barrel length about 15 cm (Approx) and butt length 13 cm (Approx) along with one (01) round ammunition marked as KF 7.65, which was loaded in the above said pistol from the possession of Ayaz Hussain @ Raj
- ii) One iron made "Ram Dao" having length 30" (approx) including butt having length 8" (approx), from the possession of Manoj Mirdha @ Raja.
- iii) One iron "Rod" having length 35" (Approx), from the possession of Bikram Saibo.
- iv) One Iron made "Dao" having length 21" (approx) including butt having length 4.5" from the possession of Bikram Saibo.

I, ASI Ashit Singha of Pradhannagar P.S, SPC would like to lodge this written complaint against the above noted accused persons to the effect that today i.e, on 12.06.2021 at 00.05 hrs while performing PC night patrolling duty I received secret source information that 10-12 persons were assembled at Dagapur football ground premises under Pradhan nagar P.S. area with deadly weapons with a view to commit some heinous crime. Accordingly without waste any time I informed the matter to you over telephone and as per your kind instruction myself along with ASI Ratan Pradhan, ASI Debasish Das, CV/223 Swapan Chettri, CV/131 Ranjan Sharma, CV/128 Ajay Sahani, CV/646 Baban Ch Das rushed to the spot to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 00.25 hrs and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. At about 00.30 hrs and we reached at Dagapur football ground compound found a group of 10/12 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing in multiple direction. Somehow, after a hot chase we could able to apprehend the 03 (three) above referred accused persons. On interrogation they persons disclosed that they along with other 8/9 associates with them had assembled there with a view to commit dacoity after making full preparation in a house at adjacent area.

found any independent witness to be present at the time of search and seizure. During search I found the following articles were seized.

- v) One iron country made Pistol, having barrel length about 15 cm (Approx) and butt length 13 cm (Approx) along with one (01) round ammunition marked as KF 7.65, which was loaded in the above said pistol from the possession of Ayaz Hussain @ Raj
- vi) One iron made "Ram Dao" having length 30" (approx) including butt having length 8" (approx), from the possession of Manoj Mirdha @ Raja.
- vii) One iron "Rod" having length 35" (Approx), from the possession of Bikram Saibo.
- viii) One Iron made "Dao" having length 21" (approx) including butt having length 4.5" from the possession of Bikram Saibo.

All the articles were seized between 00.55 hrs to 02.15 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest as they had assembled for committing dacoity under Pradhan nagar P.S. area.

Under the above circumstances, I pray before you that a specific case may kindly be started against the 03 (three) persons arrested namely 1) Ayaz Hussain @ Raj (26), S/O- Mehendi Hussain @ Metia of Gurung busty, P.S.- Pradhan nagar, Dist- Darjeeling, 2) Manoj Mirdha @ Raja (23), S/O- Manoranjan Mirdha of Debidanga bazaar, P.S. Pradhan nagar, Dist- Darjeeling, 3) Bikram Saibo (30), S/O- Lt Anik Saibo of Debidanga, Sishabari, P.S. Pradhan nagar, Dist- Darjeeling and 8/9 other persons for assembling with deadly weapons with a view to committing dacoity and arranged for its investigation.
