Sir,

I, ASI Ashit Singha of Pradhannagar P.S., Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Sushanta Chakraborty (45), S/O- Gopal Chakraborty of Baghajatin Colony, W/No-45, P.S. Pradhan nagar, Dist- Darjeeling along with i) 20 (Twenty) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, ii) 10 (Ten) bottles of Kingfisher Strong Beer containing 650ml each, iii) 09 (Nine) bottles of MdDowells No 1 Celebration Rum containing 180ml each, which has been seized under proper seizure list (enclosed herewith), to the effect that on 12.06.2021 at 08.30 hrs I received a secret source information that one person is selling illegal liquor through his shop at Baghajatin Colony near Old Shiv mandir. Accordingly I informed the matter to you and as per your kind direction myself along with ASI Debasish Das, CV-128 Ajay Kumar Sahani, CV-131 Ranjan Sharma, CV-223 Sapan Chettri all of Pradhan nagar P.S. left for Baghajatin Colony, Near Old Shiv Mandir to verify the veracity of the source information vide Pradhan nagar P.S. GDE No 613, Dated 12.06.2021 at 08.40 hrs. On reaching at the spot at 08.50 hrs and after being confirmed by the sources, I apprehended the above noted accused person. On interrogation it could learnt that since a long time he was selling illegal liquors to public, without any document or valid license for his illegal gain. Accordingly, on search his shop I recovered i) 20 (Twenty) bottles of Himalayan Gold 60up Country Spirit containing 600ml each, ii) 10 (Ten) bottles of Kingfisher Strong Beer containing 650ml each, iii) 09 (Nine) bottles of MdDowells No 1 Celebration Rum containing 180ml each. On demand Sushanta Chakraborty failed to produce any such document in respect of recovered liquors. It is a violation under Bengal Excise Act. I accordingly seized the said liquors from the apprehended person, under proper seizure List duly signed by them and the witnesses. This seizure was made in between 09.05 hrs to 10.45 hrs. Accordingly I arrested the accused person Sushanta Chakraborty (45), S/O- Gopal Chakraborty of Baghajatin Colony, W/No-45, P.S. Pradhan nagar, Dist- Darjeeling, after preparing memo of arrest and intimating the ground of arrest. At 11.10 hrs the arrested accused person along with seized articles has brought to Pradhan nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Sushanta Chakraborty (45), S/O- Gopal Chakraborty of Baghajatin Colony, W/No-45, P.S. Pradhan nagar, Dist- Darjeeling and arrange for it's investigation.
