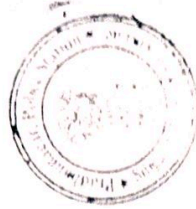

to the effect that on 12.06.2021 between 15:25 hrs to 16:55 hrs in course of performing Traffic regulation duty and special Naka checking, at Junction More P.S Pradhan Nagar, Dist: Darjeeling with Junction Traffic Guard, GDE No156/21 Dt:12.06.2021 found that the above noted persons pertaining to order to restrict the necessary movement of vehicular traffic for combating the spread of COVID-19 as per order of Chief Secretary Govt. of West Bengal vide order No. H & FW/120 Dt:22.03.2020 & GDE order No.40-3/2020-DM-I(A) Dated 24.03.2020, Loitering and plying vehicle without getting any precautionary measures for combating the spread of COVID-19, as the order has already been promulgated nation wide in order to combating the spread of COVID-19. Hence they violated the said order. Finding no any alternative way, I arrested them U/S-41 (1)(a)Cr.PC. after proper briefed them about the ground of arrest and supplied a copy of Memo of Arrest.

Hence, I would, therefore request you to kindly start a specific Case U/S-188 IPC r/w section 51(b) of Disaster management Act 2005 against the above noted accused persons and obliged.
