Subject: Written Complaint against my husband, my in-laws and his uncle and aunt for commission of mental and physical torture and cruelty upon me.

Sir,

I, Smt Sonam Mishra, Wife of Sri Anish Mishra, Daughter of Sri Sudhir Chaudhury, presently residing at ITI Road, Shastri Nagar, near Bottle Company, Siliguri, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, Pin - 734001 do hereby lodge this Complaint against my husband Sri Anish Mishra, my in-laws, my husband's uncle Sri Krishna Kumar Mishra and aunt Smt Rinku Mishra to the effect that I was married to Sri Anish Mishra, Son of Sri Firan Mishra, Resident of 100 No. Tollygunge Road, Kalighat, Kolkata, Pin - 700026 on 05.03.2017 at the house of his paternal uncle Sri Krishna Kumar Mishra and aunt Smt Rinku Mishra at Durga Nagar, Lalin Tarny Road near Borobari, Ward No. 40 of SMC, Siliguri. As per their dowry my father paid Rs. 5,00,000/- (Rupees Five Lakhs) only in cash to them at the time of marriage. Before the marriage it was stated that Sri Anish Mishra works in Indian Navy and out of such pretext I agreed to marry Sri Anish Mishra.

After the marriage my husband has taken me at his uncle's home situated at Durga Nagar, Ward No. 40 SMC, Siliguri wherein we resided for about one month. During the said period I was subjected to immense physical and mental torture on demands of dowry by my husband, my uncle Sri Krishna Kumar Mishra and aunty Smt Rinku Mishra.

In the last week of July, 2017, I went to my matrimonial house at Kolkata with my husband where my husband along with his father and mother started torturing and assaulting me for want of more dowry. I on numerous occasions was physically tortured by them for want of more dowry. In the meantime I got pregnant in the month of May, 2018 and on one occasion on the 31st day of June, 2018, I got to know that my husband is not employed with the Indian Navy and that my husband and his family members have misled and played foul upon me by falsely stating that he works in the Indian Navy which was not at all true. My husband and his family members have defrauded me by false pretexts out of which I have given my consent of marriage to him. They stated that my husband have married me with the sole intention of getting 5 lakhs from my father and they destroyed all my clothes, wearing apparels and physically assaulted me with fists and blows and I somehow rescued my life and returned back to my parental house. I have been forced to leave my matrimonial house for sake of saving my child which was in my womb.

I gave birth to male child namely Subham Mishra on the 27th day of January, 2019 at Ramkrishna Hospital, Siliguri but my husband and in-laws did not come to meet me and my child and I and my child are now leaving at the mercy of my aged parents.

I always tried to swallow all the humiliations, tortures of my husband and his family members with a ray of hope that they all will change their behavior with efflux of time and sensing my minor son's future but day by day the inhuman torture upon me escalated which became unbearable by me. Now I have finally decided to avail the remedies provided under Law and I lodge this complaint before you with a hope of getting justice.

I humbly request to kindly enquire into the matter and initiate appropriate actions against the abovenamed persons for the ends of justice.
