This has to inform you that, I am Santosh Prasad Saha  
residing at Himali Shahid Nagar, Ward N  
No. 43, dist. Jalpaiguri, P.O. Sevoke road.  
I want to report an incident which has happened  
outside my residence.

There is shop of Momo's, so many people used to  
smoke and drink use abusive language.  
I went outside my house to stop them, instead  
of talking they started fighting with me and  
with my family. They attacked my daughter and  
son with beer bottle, cricket stumps and some  
sharp utensil. My daughter started bleeding heavily  
and my son got injured too. They also attacked  
me with so many peoples including his family.  
There were around 8 to 10 people, all were attacking  
and beating and even using abusive language  
to the females of my family. I have identified  
3 of them namely Md. Sonu S/O Elias, Md. Sujad  
S/O Zakir Khan and Md. Chatur S/O Elias.  
They also threaten and challenged my family and my  
sons that they will kill them whenever they find  
bound them.
