It is respectfully submitted that:

- The complaint is being filed by me, Rajib Biswas, Son of Late Shyamal Biswas, currently
 working as Deputy General Manager (Retail Sales) at Indian Oil Corporation Limited and
 addressed at Indian Oil Corporation Limited, Divisional Office, SJDA Paribahan Nagar,
 Matigara, Siliguri- 734010, District: Darjeeling, (West Bengal) to bring to your attention the
 following.
- 2. This complaint is being instituted to report to you and seek investigation of offences committed by the persons named herein belowinter alia, under sections 405, 415,420 read with 120B of the Indian Penal Code, 1860 (IPC) for commission of cognizable offences of cheating, criminal breach of trust and criminal conspiracy:
 - (i) Celica Automobiles Private Limited (Celica Automobiles), a company registered under the Companies Act and addressed at Annapurna Annex, Opp. Vishal Cinema Hall,2nd Mile, Sevoke Road, Siliguri – 734001.
 - (ii) Mr. Debraj Biswas, Son of Sri D. N. Biswas working as the Manager of Celica Automobiles and addressed at Annapurna Annex, Opp. Vishal Cinema Hall, 2nd Mile, Sevoke Road, Siliguri – 734001.
 - (iii) Mr. Kalyan Kumar Bose, Mr. Balkrishan Saria, Mr. Adarsh Tulshan, Mr. Vedant Khaitan, Mr. Nikhil Alok Gupta. All directors of Celica Automobiles and addressed at Park Center Building, 9th Floor, 24 Park Street, Kolkata -700016.



He further assured me that the Jeep Compass would be the ideal and most comfortable vehicle for me and alsofor my families' needs and match my status as a comfortable vehicle for me and alsofor my families. - 3. The brief facts leading up to the filing of the instant complaint for the offences as complained of herein, are as under:
 - (i) That some time in the last week of February 2021/ early March 2021, one Mr Debraj Biswas. Son of Sri D. N. Biswas, approached me and introduced himself as the Manager of one Celica Automobiles, the dealer of Jeep Compass Vehicle which is manufactured in India by FCA India Automobiles. He made tall claims about the Jeep Compass car and induced me to purchase the said car by claiming that the Jeep Compass is an "extraordinary" car loaded with features and comfort that no other car in the market offers. He thenpresented with various advertisement material including an official brochure of FCA India Automobiles.
 - (ii) The said Mr. Debraj Biswas, for and on behalf of the management of Celica Automobiles and FCA India Automobiles assured me and made me believe that the said Jeep Compass car would require little to almost no maintenance and upkeep costs during the first few years. The said Mr Debraj Biswas, for and on behalf of the above named persons also claimed about the manufacturing capabilities, techniques and the quality of the said cars built and delivered by them and he explained me that this is for this precise reason that the said manufacturer and the dealer charges an exorbitant price for the so-called premium cars manufactured and sold by them which

- (iii) That sir, I was specifically told and represented by the employees of Celica Automobiles that I will be delivered a brand-new car and that they would not give/ sell me a car from their old stock.
- (iv) Sir, on being induced by the said Mr Debraj Biswas for and on behalf of his superiors, the above named persons, I decided to purchase the said Jeep Compass car for my personal needs and use and with an intention to avoid public transport during the Covid-19 pandemic. Accordingly, I contacted with several financier to arrange for the required funds. I got the sanction of the loan amount from State Bank of India, Siliguri Branch on 05.04.2021 and that the said Mr Debraj Biswas for and on behalf of the said manufacturer and the dealer delivered me a Jeep New Compass Car (Limited (O) edition brilliant black color) having the Chassis No.MCANJPCH8MFA72479*3M and Engine No. 2796698 on 05.04.2021 vide its Tax Invoice bearingNo. CAPL/10/2021/33 dated 31.03.2021 for an amount of INR 23,56,543/- (inclusive of taxes).
- (v) I paid the price of the said Car from and out of my hard-earned life savings along with the funds loaned by me from the said State Bank of India Siliguri Branch. I also paid an additional amount of INR 2,02,584/= for obtaining the government registration and an amount of INR 62,028/- for obtaining a year-long insurance cover and the car was registered vide vehicle number WB 74 BF 4455. A sum of Rs.50,000/= was also incurred for getting interior products of the car and other protective equipment such as floor mat, seat cover, etc.
- (vi) That Sir, just within few days of purchase, the car started troubling me in as much as there was a severe problem while starting the car/ switching on the engine and it also started to make unusual noise and leakage and the doors of the car also started to get jammed very frequently. As a result of which I had/have to rush the car to the workshop for inspection and necessary repair amidst the Covid-19 pandemic several times. A technician initially visited my residence to fix the problems, but he failed and the car was ultimately taken to the workshop on 19 April 2021 i.e. just after two weeks of purchasing the car and by the time the car had only run for about 34 kms. I had explained all the problems and issues with the said alleged 'new' car in detail to the personnel present in the workshop and made an earnest request to thoroughly check the car and carry out the necessary repairs and replacements. Thereafter, I was assured that the car would not give rise to any more complaints. However, given that

the car had some major inherent defects, the problems communed, and I had have constantly called up the Dealer for assistance and repairs.

- (vii) Sir, it is undeniable that despite being within the warranty period, the car gave persistent problems since day one and has been lying in an inoperative and unworkable condition in the workshop till date. It will not be out of place to mention that during this time, I had/have made umpteen number of phone calls and written several emails to air out my disappointment and grievances with the car manufactured by the manufacturer and sold by the dealer through the said Mr Debraj Biswas. The emails sent by me including the legal notice to the said responsible persons are reiterated and ought to be treated as part of this complaint, the contents of which are not reproduced berein for the sake of brevity.
- (viii) Sir, since after purchase of the car, the car has remained an enigma. In the short span of about two months, several technicians visited my residence for repair and that the car was taken to the workshop on three different occasions for thorough examination, inspection, and repairs. In the last two months, the car has /had a running of merely 164 kms, out of which more than half of the running has been on account of test driving and taking the car from my residence to the workshop and back. As such, I the undersigned or my family members have hardly driven the car and has only been paying the installments on loan availed for purchasing the luxury car. Sir, all these events have fortified my doubt and I am now confident that the car had/ has some manufacturing/ inherent defect since the time it has been delivered to me and that the dealer's workshop has been merely carrying out some temporary band-aid solutions which does not last for more than just few days.
 - (ix) Recently, I have scrutinized the papers supplied by Celica Automobiles and Mr Debraj Biswas, who was/is working for and on behalf of the above named persons of the manufacturer and dealer company responsible for doing their business for commercial purposes, and came to know that the said persons in collusion with each others have conspired against me and sold their old vehicle instead of new Jeep Compass and took/received the value of the said vehicle as the price of new vehicle and cheated me with their dishonest and fraudulent intention. I say this because the said State Bank of India, Siliguri Branch sanctioned the loan amount only on 05.04.2021 whereas the said dealer company had/has raised its tax invoice on 31.03.2021, that is about 5 days prior to the date of sanction of the said loan amount. This clearly shows that I was misrepresented by the officials and employees of Celica Automobiles and FCA India Automobiles from their wrongful gains and hoodwinked into purchasing the old car instead of new car. The service history of the car in a short span of two months itself make it clear that I was sold an old/ used car.

- At the time of purchasing the said vehicle, had I known that the above-named persons would not deliver me a new vehicle being new Jeep Compass and would deliver an old car with some inherent manufacturing defects that would give me constant trouble (x) and I would be deprived from enjoying and using the said vehicle by paying such huge amount, I would not have agreed to purchase the said vehicle by paying a huge amount of INR 26,71,155/-. It is clear from the act and conduct of the said persons that the said Mr Debraj Biswas, in collusion with his superior officers, directors and other responsible persons of the said company had/have conspired against me and sold the said old vehicle as new vehicle with their dishonest and fraudulent intention and have cheated me.
 - I verily believe that the fraud and cheating of such a nature is unlikely to have happened without the knowledge and active participation and involvement of the higher officials and directors of Celica Automobiles and FCA India Automobiles. (xi) The accused persons named above have collectively hatched a convoluted scheme in secreey to cheat and defraud me and rob me of my hard-earned money by selling me a sub-standard and a used car instead of a new car for their wrongful gains.
 - I also strongly apprehend that the accused persons named herein above may have also tried to cheat and defraud other customers by selling them old and un-used cars instead of selling them new Jeep Compass cars. It is for this reason as well that your good office ought to take cognizance of this and take appropriate action so that the accused named here do not cheat and dupe other customers.
 - 4. That in view of the facts and circumstances narrated hereinabove, I most earnestly request you to kindly register an F.I.R. against the accused persons named hereinabove and to investigate the matter to unearth the larger scam, and if the accused persons are indeed found guilty, ensure the prosecution and punishment of the accused persons and any other person involved in the commission of the offences outlined above, in accordance with law. I remain available for any assistance or information that you may require in this regard.
