

Sir,

In producing here with five arrested accused persons namely 1) Sonu Sahani (19) s/o Dhaneshwar Sahani of Darjeeling More, PS- Pradhannaar Dist- Darjeeling, 2) Rijul Sahani (18) s/o Biteshwar Sahani of Dagapur, PS- Pradhannagar Dist- Darjeeling, 3) Biki Paswan (18) s/o Upendra Paswan of Dagapur, P/s- Pradhannagar, Dist- Darjeeling, 4) Anand Sahani (20) s/o Mohon Sahani of Dagapru, Bandrijote, Ps- Pradhannagar, Dist- Darjeeling, 5) Dilkhush Singh (18) s/o Ashok singh of Gyanjyoty More PS- Pradhannagar, Dist- Darjeeling arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 13.06.2021 while performing K30-II van vide GDE No.677 Dated 13.06.2021 I found that the above noted person was gathering and loitering without wearing mask at Near Seven Kingdom under Pradhan nagar P.S. As they violated the order No.-647-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3<sup>rd</sup> June, 2020 and Memo No 486-CS/2021 dated 24<sup>th</sup> April, 2021 Promulgated by Govt. of West Bengal to Laboratory and Combat with the spread of Covid-19.

I along with force apprehended them finding no other alternative and I arrest them U/S 41C.rPC.On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
