Subject: FIR

In producing herewith five (05) arrested accused persons namely (i) Aktarul(19), S/O- Faimuddin, of Bahadi Gachh, PO. Kuchila PS. Chopra, Dist. Uttar Dinajpur (ii) Munna Sah (21), S/O- Krishna Sah of Darjeeling More, Gas Godown PO. Pradhannagar, PS. Matigara, Dist. Darjeeling (iii) Bahadur Roy(18), S/O- Gopal Roy of Darjeeling More, Gas Godown PO. Pradhannagar, PS. Matigara, Dist. Darjeeling (iv) Ashish Thapa(21) S/O Lt. Ratan Kumar Thapa of Testa Old Bazar, PS. Testa, Dist. Kalimpong and (v) Md. Akbar Islam(20) S/O Md Majbur of Tari Jote, PO- New Rongia, PS. Matigara, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 34 inch (approx) including butt from the possession of Aktarul which was kept concealed on his back side,
- (2) One iron made sword measuring 29 inch (approx) including wooden butt from the possession of Munna Sah which was kept concealed on his back side,
- (3) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Bahadur Roy which was kept concealed on his back side,
- (4) One iron made 'Knife' measuring 11 inch (approx) from the possession of Md. Akbar Islam which was kept on his right hand,
- (5) One iron made 'Kukri' measuring 13 inch (approx) from the possession of Ashish Thapa which was kept on his right hand,
- (6) Two iron made Crowbars measuring 25 inch (approx) and 31 inch (approx) in length found from the place of occurrence.

I, ASI Nitai Ch. Mandal, S/O- Lt. Gobinda Mandal of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Aktarul, ii) Munna Sah, iii) Bahadur Roy, iv) Ashish Thapa, (v) Md. Akbar Islam and others namely Md Lalon, Rusto Ali, Md. Alongir, Md. Jakhir, and Prasanjit to the effect that today on 13.06.2021 at 00.05 hrs received a sources information that 14/15 youths have assembled at Paribahan Nagar, back side of dhaba under Matigara PS with a view to commit dacoity in a house at Himachal Bhiar. The fact was diarized in GD vide Matigara PS GDE No- 577 dated 13.06.2021. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI- Subhendu Das, C/986 Rajib Sarkar C/1008 Kanak Roy, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information. At about 00.25 hrs after reaching near Jubilee Petrol Pump under PS- Matigara I met my source and being pointed by the source we started walking towards Paribahan Nagar. At 00.55 hrs we reaching Paribahan Nagar, back side of dhaba started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Himachal Bhiar area.

I thereafter, seized the above noted weapons under proper seizure list and labelled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.25 hrs to 02.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Himachal Bhiar area. It is also revealed from them that Md Lalon, Rusto Ali, Md. Alongir, Md. Jakhir, and Prasanjit and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. i) Aktarul(19), S/O- Faimuddin, of Bahadi Gachh, PO. Kuchila PS. Chopra, Dist. Uttar Dinajpur (ii) Munna Sah (21), S/O- Krishna Sah of Darjeeling More, Gas Godown PO. Pradhannagar, PS. Matigara, Dist. Darjeeling (iii) Bahadur Roy(18), S/O- Gopal Roy of Darjeeling More, Gas Godown PO. Pradhannagar, PS. Matigara, Dist. Darjeeling (iv) Ashish Thapa(21) S/O Lt. Ratan Kumar Thapa of Testa Old Bazar, PS. Testa, Dist. Kalimpong and (v) Md. Akbar Islam(20) S/O Md Majbur of Tari Jote, PO New Rongia PS. Matigara, Dist. Darjeeling (vi) Md Lalon, (vii) Rusto Ali, (viii) Md. Alongir, (ix) Md. Jakhir, (x) Prasanjit, and others and arrange for its investigation.
