Sir,
In producing herewith arrested accused person named Mithun Singha(M/36yrs),
S/O- Lt Baldeb Singha, of Kawakhali Bazar PO - Sushruta Nagar, PS - Matigara,
Dist - Darjeeling along with copy of memo of arrest and seized articles viz (i)
16(Sixteen) bottles of Sealed Himalayan Gold Bottles 60Up Country Spirit each
containing 600 ML Rs. 100/- each totaling amount of Rs 1600/- with proper police
escort.

Today i.e 12/06/2021 at 19:15 hrs I, SI Maheswar Ch. Paul of NBMC OP along with
C/1071 Sumit Sherpa, CV/158 Partha Sarkar, CV/ 920 Kamal Barman while
conducting special raid against anti social elements, warrantees, ID liquor etc in
vehicle no WB74/8035 at different area under NBMC OP in course of which I
received an information from source that one person is selling Liquor illegally in
huge quantity in a clandestine way in the hotel of Mithun Singha at Kawakhali more.
As soon as after receiving information I informed the matter to O/C NBMC OP and as
per his order and instruction I along with force conducted raid in the hotel of Mithun
Singha Kawakhali more During raid I found one Mithun Singha(M/36yrs), S/O- Lt
Baldeb Singha, of Kawakhali Bazar PO - Sushruta Nagar, PS - Matigara, Dist -
Darjeeling is (i) 16 (Sixteen) bottles of Sealed Himalayan Gold Bottles 60Up Country
Spirit each containing 600 ML Rs. 100/- each totaling amount of Rs 1600/- hidden
inside his shop and selling it to the customers in concealed manner. Accordingly, I
seized the above noted articles in presence of police witnesses, I demanded papers
and license / cash memo of those seized articles but he failed to produce any
documents in support of his possession of above noted illicit liquor. On interrogation,
he disclosed his name as mentioned above and admitted that he procured the liquor
illegally and had been selling the same illegally to the people. I, accordingly, seized
those illicit liquors U/S 102 CrPC in presence of witnesses after preparing proper
seizure List duly signed by the witnesses as well as the accused and also labeled the
same. Then, I arrested her U/S 41 CrPC with help of police personnel. The search,
seizure and label were made from 19.40 hrs to 19.55 hrs. Then we left the place with
the arrested person and the seized articles.

Under the above circumstances I pray before your kind self that a specific case under
proper section of law may kindly be initiated against the accused person named
Mithun Singha(M/36yrs), S/O- Lt Baldeb Singha, of Kawakhali Bazar PO - Sushruta
Nagar, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
