Sir,

I, SI Hiru Kanti Sarkar of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against namely; (1) Alex Khatri (26) S/O Bikram Khatri of Singmari Bazar, PS- Sadar Dist- Darjeeling, (2) Bivek Sherpa (25) S/O Tenzing Sherpa of Rambhi, PS + Dist- Kalimpong, (3) Dipak Das @ Napu (24) S/O Late Dilip Das of Fuleswari, Ward No. 24, PS- Siliguri, Dist- Darjeeling (4) Nandu Tirkī (23) S/O Saharoy Tirkī of Bagrakot Chittaranjan Colony, Ward No. 18, PS- Siliguri, Dist- Darjeeling and (5) Ram Ghosh (20) S/O Swapan Ghosh of do under arrest along with following seizure articles; (i) One (01) knife measuring approx. 14" including handle recovered from the possession of Alex Khatri (knife was on his hand) (ii) One iron rod measuring approx. 25" pointed at one end (seemed to be implement of house breaking) recovered from Bivek Sherpa, (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Dipak Das @ Napu which he was holding on his hand and (iv) One Sword measuring approx 26 "including handle recovered from the possession of Nandu Tirkī, v) One rope measuring 10 fit recovered from the possession of Ram Ghosh.

In this regard, I beg to report that on 12.06.21 at 01.45 hrs received secret reliable source information that about 12/15 anti socials armed with deadly weapons assembled at Vivekananda road near Rajasathan Guest House under Siliguri PS for making preparation to commit dacoity at Khalpara area. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No. 690 Dated 12.06.21. As per the direction of IC Siliguri PS, at 02.05 hrs, I along with ASI Siben Sarkar, ASI Subir Sen, CV/283 Prosenjit Dey, CV-622 Ramanath Barman left for working out the information vide Siliguri PS GDE No. 692 Dtd. 12.06.21 after briefing officers and force properly and also along with required papers / articles. At 02.15 around hrs we reached near Rajasthan Guest house and kept our vehicle at considerable distance. Then, I along with Officers and force headed towards Vivekananda road near Rajasathan Guest House looking for witnesses, if any on the way and found nothing. By this time we reached Vivekananda road near Rajasathan Guest House, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted five persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted

above and admitted that they along with 7/9 others assembled at the spot making preparation to commit dacoity tonight at Khalpara area. I accordingly searched them in presence of witnesses and found (i) One (01) knife measuring approx. 14" including handle recovered from the possession of Alex Khatri (knife was on his hand) (ii) One iron rod measuring approx. 25" pointed at one end (seemed to be implement of house breaking) recovered from Bivek Sherpa, (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Dipak Das @ Napu which he was holding on his hand and (iv) One Sword measuring approx 26 "including handle recovered from the possession of Nandu Tirki making and v) One rope measuring 10 fit recovered from the possession of Ram Ghosh preparation for committing Dacoity tonight in Khalpara area but others managed to escape. Accordingly, I seized above noted weapons in presence of witness under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 03.15 hrs to 03.45 hrs of dated 12.06.21.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at nearby Milnapally area.

Further, it to mention here that the arrested accused persons are well known anti socials and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against (1) Alex Khatri (26) S/O Bikram Khatri of Singmari Bazar, PS- Sadar Dist- Darjeeling, (2) Bivek Sherpa (25) S/O Tenzing Sherpa of Rambhi, PS + Dist- Kalimpong, (3) Dipak Das @ Napu (24) S/O Late Dilip Das of Fuleswari, Ward No. 24, PS- Siliguri, Dist- Darjeeling (4) Nandu Tirki (23) S/O Saharoy Tirki of Bagrakot Chittaranjan Colony, Ward No. 18, PS- Siliguri, Dist- Darjeeling and (5) Ram Ghosh (20) S/O Swapan Ghosh of do and 7/9 others who fled away under proper section of law and to cause its investigation.
