In producing here with the accused person namely-1) Nagma Khatun (28) yrs, W/O-Irsad Ali @ Aktar of Adarsa Nagar, Near Govt. saw mill, ward No-4, P.S-Siliguri, Dist. Darjeeling, along with lap her one daughter namely-i) Terana Khatun (6 month) yrs. And son namely-ii) Sohel Ali (9) yrs. And 2) Rubi Khatun (23) yrs. D/O- Islam Ali of -do-, along with seized (i) 42 (Forty two) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount of Rs-4200/- (Forty Two hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1"

The fact of the case is that today (12-06-.21) myself along with force and lady constables while performing special raid against illegal alcohol, at 06.30 hrs, I received a source information that the above noted Lady persons namely- 1) Nagma Khatun (58) yrs, S/O-Irsad Ali @ Aktar of Adarsa Nagar, Near Govt. saw mill, ward No-4, P.S-Siliguri, Dist. Darjeeling, And 2) Rubi Khatun (23) yrs. D/O- Islam Ali of -do-, they are selling huge alcohol in the house of the ac Person at Adarsa Nagar coloney, Siliguri, Under Khalpara TOP without any valid license and documents in higher price than the actual value for their illegal gain. Accordingly I informed the fact to I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for at Adarsa Nagar, Siliguri, in the house of accused persons, P.S-Siliguri, Dist. Darjeeling to verify the veracity of the information vide Khalpara TOP GDE No-356/21 Dated-12-06-.21. After reaching at Adarsa Nagar, Siliguri, Darjeeling at 07.25 hrs and as shown by the source, I found the above noted persons were selling liquor secretly to different persons and seeing the Police party the above noted persos try to flee away but we managed to intercept them . On being asked the above noted persons disclosed their identity as mentioned above. During search, I could recover the above noted alcohol kept in the house of the accd. Person a gunny bag. During interrogation they admitted that they were selling alcohol for their wrongful gain. On demand they failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted persons are selling alcohol illegally since long. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labeled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused persons U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 07.45 hrs to 08.25 hrs On 12-06-21.

Under the circumstances one specific case may kindly be started against the arrested accused person namely- 1) Nagma Khatun (58) yrs, S/O-Irsad Ali @ Aktar of Adarsa Nagar, Near Govt. saw mill, ward No-4, P.S-Siliguri, Dist. Darjeeling and 2) Rubi Khatun (23) yrs. D/O- Islam Ali of -do- for the possessing and selling alcohol illegally and arrange for its investigation of the case.
