Sir,

In producing herewith one arrested accused person namely Ram Chandra Singh (M/63) S/O-Lt Ganesh Singh of Lowerr Bhanu Nagar, (Near Shibe Mandir), Ward No 43, PS Bhaktinagar, Dist-Jalpaiguri along with seized articles (i) 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed, MRP Rs. 100/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL. N-) 01

I, ASI biswajit Ghosh of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 12/06/2021 at 16:35 hrs during special raid duty I received a secret source information that, one person is carrying huge quantity of country spirit through Sevoke road, Near Sunny Tower towards Lower Bhanu Nagar. Accordingly I informed the information to OC Panitanki TOP and as per his direction I along with, ASI Ratan Ghosh, C/702 Latifur Rahaman, CV/1008 Bikash Chowdhury left for PO to work out the information. On arrival at Sevoke road, Near Sunny Tower at 16:55 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold of 600 ml each when packed which was kept in a Nylon Bag. On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local public of Bhanu Nagar and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized 19 (Nineteen) Bottles of 60 UP Country Spirit styled as Himalayan Gold with Nylon Bag which was used for carrying the seized articles under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 17:05 hrs to 17:25 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1900/-

Hence, under the above circumstances I am submitting this written complaint against the above accused person namely Ram Chandra Singh (M/63) S/O-Lt Ganesh Singh of Lowerr Bhanu Nagar, (Near Shibe Mandir), Ward No 43, PS Bhaktinagar, Dist-Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
