Sir,

In producing herewith five (05) arrested accused persons who disclosed their name & identity as (i) Mukul Roy (18 yrs) S/O- Madan Roy of Sraban Nagar, Subashpally, Ward No-18, PS-Siliguri, Dist-Darjeeling, (ii) Uttam Saha (42 yrs) S/O- Biren Saha of Fulbari, near 10th Bn. Dabgram, PS-NJP, Dist-Jalpaiguri, (iii) Ram Krishna Das (36 yrs) S/O- Ajit Kr. Das of South Bharat Nagar, Debasish Colony, Ward No-24, PS-Siliguri, Dist-Darjeeling, (iv) Bipul Halder (36 yrs) S/O- Sadeb Halder of Barivasa, Madani Bazar, PS-Bhaktinagar, Dist-Jalpaiguri and (v) Biru Khati (21 yrs) S/O- Basant Khati of Debidanga, babubhasa, PS-Pradhan Nagar, Dist-Darjeeling along with three TOTO viz- (i) Toto blue colour without number, (ii) Toto yellow colour without number & (iii) Toto green colour without number. I, SI Mihir Majumder of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 12.06.2021 at 17.45 hrs during my R/T Mobile Van duty had been to Mahabirasthan area near Rail gate, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons. Three of them namely Uttam Saha, Ramkrishna Das and Bipul Halder were roaming with their TOTOs noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
