Bhagaban Das of Rishi Arabinda Road Bylane Near Pradhan Building, Ward No. 12, Hakimpara, PS- Siliguri, Dist- Darjeeling (4) Mani Kumar Darjee (43) S/O Lt. Harka Bahadur Darjee of Anehal More, Iskon Mandir, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri (5) Raju Barman (31) S/O Amin Barman of Dakshin Shanti Nagar, Housing Quarter, PS- Bhaktinagar, Dist- Jalpaiguri under arrest.

I, SI Ashim Kr Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 12.06.2021 at about 18:35 hrs while performing mobile petrolling duty at Bidhan Market Auto Stand area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Anil Ghosh(52) S/O Lt. Balai Ghosh of Baba Loknath Sweets, Bidhan Road, Ward No. 11, PS- Siliguri, Dist- Darjeeling (2) Mustak Ali (21) S/O Kamal Hussain of Vill- Kuli Para, PO- Ramshimul, PS- Harischandra Pur, Dist- Malda (3) Arun Gupta (43) S/O Lt. Bhagaban Das of Rishi Arabinda Road Bylane Near Pradhan Building, Ward No. 12, Hakimpara, PS- Siliguri, Dist- Darjeeling (4) Mani Kumar Darjee (43) S/O Lt. Harka Bahadur Darjee of Anehal More, Iskon Mandir, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri (5) Raju Barman (31) S/O Amin Barman of Dakshin Shanti Nagar, Housing Quarter, PS- Bhaktinagar, Dist- Jalpaiguri.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Hence, they violated the order of the Govt. of West Bengal duly promulgated in order No. 647- ISS/2M-22/2020 dated 15.05.2021 The above noted person has intentionally refused to comply with the Govt. order duly promulgated in view of break-out of pandemic COVID-19 throughout the State. Accordingly, I arrested the above noted accused persons U/S 41 Cr. P. C.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Anil Ghosh(52) S/O Lt. Balai Ghosh of Baba Loknath Sweets, Bidhan Road, Ward No. 11, PS- Siliguri, Dist- Darjeeling (2) Mustak Ali (21) S/O Kamal Hussain of Vill- Kuli Para, PO- Ramshimul, PS- Harischandra Pur, Dist- Malda (3) Arun Gupta (43) S/O Lt. Bhagaban Das of Rishi Arabinda Road Bylane Near Pradhan Building, Ward No. 12, Hakimpara, PS- Siliguri, Dist- Darjeeling (4) Mani Kumar Darjee (43) S/O Lt. Harka Bahadur Darjee of Anehal More, Iskon Mandir, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri (5) Raju Barman (31) S/O Amin Barman of Dakshin Shanti Nagar, Housing Quarter, PS- Bhaktinagar, Dist- Jalpaiguri arrange for its investigation.
