Respected Sir, with due respect I, Smt. Champa Chatterjee, wife of Bramosh Chatterjee, Resident of Dugadas Colony, Shubhashally, S.O. & P.S. Siliguri, Dist- Darjeeling do hereby want to inform you that on 4-06-2021 at about 8:30 pm when my husband was not at home the abovesaid persons came to my house and started abusing us verbally with various intolerable filthy languages and on pretext they all started one and my son physically with both fist and blows. They also beat my son with wooden sticks upon which he sustained several injuries. Later he was admitted at Siliguri District Hospital and further medical treatment was started. It is pertinent to mention here that on previous occasions also the abovesaid persons on 9-04-2021 assaulted my family members and myself with fist and blows physically and they all in conspiracy dragged me by my hair to the verandah of my house and the abovesaid Bapi Saha, Sonmath Saha and Bishwanath Saha man-handled me and harassed me partly and slapped me on my face continually.

Sir, they are very dangerous and have associates with hooligans. After seeing this the local rescued me and took me to Siliguri Hospital for treatment.

So, I, therefore request you to take necessary legal actions against all the above named persons according to the law as early as possible and protect me and my family members from their cruelty.
