In producing herewith nine (09) arrested accused persons who disclosed their name & identity as (i) Ranjit Sutradhar (40 yrs) S/O- Lt. Kushi Mohan Sutradhar of Rathkhola Math, Ward No-22, PS-Siliguri, Dist-Darjeeling, (ii) Ajit Sutradhar (60 yrs) S/O- Lt. Kushi Mohan Sutradhar of Rathkhola Math, Ward No-22, PS-Siliguri, Dist-Darjeeling, (iii) Anuj Sah (20 yrs) S/O- Manish Sah of Ganganagar, Road No-2, Ward No-V, PS-Siliguri, Dist-Darjeeling, (iv) Pradip Das (42 yrs) S/O- Lt. Bijay Das of 1 No Dabgram, near Matrisadan, Ward No-23, PS-Siliguri, Dist-Darjeeling, (v) Arbind Maheswari (59 yrs) S/O- Radhe Shyam Maheswari of Milanpally, near Goriya Math, Ward No-26, PS-Siliguri, Dist-Darjeeling, (vi) Md. Rahaman (25 yrs) S/O- Md. Bismillah of Koiladepot, Khalpara, Ward No-7, PS-Siliguri, Dist-Darjeeling, (vii) Md. Arman (18 yrs) S/O- Md. Bismillah of Koiladepot, Khalpara, Ward No-7, PS-Siliguri, Dist-Darjeeling, (viii) Smt. Jharna Das (42 yrs) W/O- Ganadhar Das of Green Park Mallaguri, Ward No-46, PS-Pradhannagar, Dist-Darjeeling and (ix) Ranjit Das (24 yrs) S/O- Ganesh Das of Michal Madhusudan Colony, Fulbari-I, PS-NJP, Dist-Jalpaiguri along with two TOTO bearing Nos viz- (i) Toto red colour bearing Reg No- WB 73F/2143 & (ii) Toto deep blue colour bearing No- WB 73F/2707. I, SI Gopal Chandra Mandal of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 13.06.2021 at 12.25 hrs during my R/T Mobile Van duty had been to Rathkhola and Venus More area, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons. Two of them namely Smt. Jharna Das and Ranjit Das were roaming with their vehicles noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
