I, Smt. Punam Prasad, W/o - Sri. Deepak Jaiswal, Govt. Teacher by Profession, resident of Rani Bhawan, Seth Sital Market, Ward No. XI M. Corp. Area, P.S. Siliguri, Dist: Darjeeling, would like to inform you that I am residing in the above mentioned address with my husband and my daughter, and we have four storied building in which we are residing in the first floor, that today (13-06-2021), morning at about 7:45 A.M. when I was coming down stairs from the roof of my building taking some flowers for doing puja at that time my brother-in-law namely Pankaj Jaiswal S/o - Lt. B.P. Jaiswal, who resides in the same building in second floor with his family, has hanged curtains in the common area near stairs and that area becomes dark and when I remove the curtains for passing light from outside then my brother-in-law as above named came suddenly and started physically assaulting me, he hold my left hand and started twisting and also pull my hair and also tear my clothes (suit), and also hit in my white body and I have got internal injuries.

That previously he had done this type of incident before near about two years ago and at that time I had lodged one F.I.R. against my brother-in-law as above named on dated - 15-09-2018,
