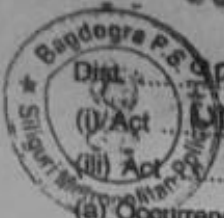

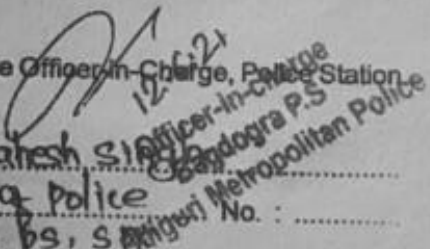

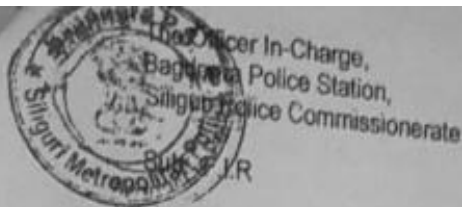

Sir,

In producing herewith arrested 01(One) accused person namely; 1) Pabitra Singha 24yrs s/o Ganesh Ch Singha Vill: Salkavita N.B.U, PS, Matigara Dist-Darjeeling along with the following article seized under proper seizure list that:

- (a) 01(One) cartoon containing total 147 (one hundred forty seven) bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup having batch No TBHU0272, Mfg Date 02/2021 and Exp Date 01/2023 styled as Lykarex cough syrup each bottle containing 100ml. Marked as Exhibit- "A", and 01(One) bottle Chlorpheniramine Maleate & Codeine Phosphate Syrup having batch No TBHU0272, Mfg Date 02/2021 and Exp Date 01/2023 styled as Lykarex cough syrup randomly taken out and Marked as Exhibit- "A 1".
(Total Codeine Phosphate weighing 14.7 grams)

I, SI Dipanjan Bhadra of Bagdogra P.S. S.P.C do hereby lodge a written complaint against the above mentioned arrested person to the effect that today on 12.06.2021 at 21.50 hrs, I along with force C/778 Kamal Lama CV/ 386 Kishore Ranjan Howlader left for PS, to perform Naka checking duty at Bihar more under Bagdogra PS, vide Bagdogra PS, MCC No 1550 /2021 Dtd, 12.06.21 in course of Naka checking around 22.05 hrs one two wheeler Motor Cycle steel color styled as Hero Honda Super Splender coming towards Bihar More from Naxalbari side and one person aged about 23 yrs was riding the said motor cycle and back side of his bike the arrested person sited with one big size cartoon tide with white nylon plastic rope on his lap as a suspicious manner on signal the rider of said motor cycle stopped the bike in front of us we disclosed our identity as Police from Bagdogra PS, on asking what is inside the cartoon the arrested person unwilling to open the said cartoon and tried to fled away from the spot to left his cartoon we cordon him and force him to open the said cartoon at that moment another one who seated on the said two wheeler motor cycle managed to escape with his two wheeler motor cycle in a high speed. On interrogation he disclosed his name and address as noted above and the bike rider of his friend Koushik. In this situation, I called K-36 QRT night van party over phone on request to come down at Bihar more for help. After some time LSI Supriya Barman along with force arrived at Bihar more, I interrogation what he was carrying inside the said cartoon, on asking he disclosed that some house hold articles inside the cartoon which was purchased from Panitanki area under Naxalbari PS, for use his house there are strongly reason to believe that he was carrying NDPS substance. On repeated asking he open the said big size cartoon and found that huge bottle of contraband article NDPS substance of drugs Codeine Phosphate Syrup on the said cartoon. On repeated interrogation he confessed that the above noted drugs purchased from Panitanki for sell in Shibmandir Matigara area to his some designated drug addicts customers. Accordingly, I called two persons those were standing near Bihar more namely (i) Swarup Debnath 22yrs s/o Subash Debnath of Paticolony Road No-6, PS, Matigara, Dist. Darjeeling (ii) Santu Paul 30yrs s/o Basudev Paul of Paticolony Road No-6, PS, Matigara, Dist. Darjeeling and shared the information with them and requested them to be present as witness during search and seizure, if any and both agreed with the proposal, I then gave option notice to Pabitra Singha in writing as per provision of the law that whether he wanted to be searched in presence of an Executive Magistrate or Gazetted Officer and he gave in writing that he would prefer to be searched in presence either an Executive Magistrate or Gazetted Officer. Accordingly, I informed the matter to O/C Bagdogra PS and he informed me over mobile phone to send one requisition to Shri. Chandan Das, Asstt. Commissioner of Police, West Zone, Siliguri Police Commissionerate as per his kind instruction at 22.15 hrs, I sent a letter through C/778 Kamal Lama to Shri. Chandan Das, Asstt. Commissioner of Police, West Zone, SPC, who was deputed as Special Executive Magistrate of SPC, informing him regarding the apprehension and detention of the said accused person with possessing of huge quantity of NDPS substance drugs Codeine Phosphate Syrup NDPS substance drugs and requested him to come down at Bihar More, Naka checking point under Bagdogra P.S, SPC as Special Executive Magistrate of SPC on that day and to supervise the search and seizure and to perform Magisterial function.

At about 22.55 hrs Shri. Chandan Das, Asstt. Commissioner of Police, West Zone, Siliguri Police Commissionerate, arrived at the spot in Bihar More to perform magisterial function and he disclosed his name and designation and informed both the witnesses and apprehended accused person that he was present to perform Magisterial function. I offered the independent witnesses and the accused person to search our Police Party as per provisions of law but they refused to search the police party. Then after, in presence and under the supervision of Shri. Chandan Das, Asstt. Commissioner of Police, West Zone, Siliguri Police Commissionerate, I searched the apprehended person Pabitra Singha to maintain all decency and on search of big size cartoons recovered the above noted seized articles i.e. total 147 (one hundred forty seven) bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup having batch No TBHU0272, Mfg Date 02/2021 and Exp Date 01/2023 styled as Lykarex cough syrup each bottle containing 100ml. Marked as Exhibit- "A". Total Codeine Phosphate weighing 14.7 grams. On demand he failed to produce any valid documents or license possession and carrying of huge quantity of NDPS substance drugs Codeine Phosphate Syrup. Accordingly, I seized the above noted NDPS substance drugs under proper seizure list duly signed by him as well as the witnesses. Out of one bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup having batch No TBHU0272, Mfg Date 02/2021 and Exp Date 01/2023 styled as Lykarex cough syrup. Randomly taken as sample and Marked as Exhibit- "A-1". Value of above noted NDPS substance Codeine Phosphate Syrup Rs, 20,580/=

In presence and under the supervision of Shri. Chandan Das, Asstt. Commissioner of Police, West Zone, Siliguri Police Commissionerate and in presence of witnesses and accused person, I seized the above noted NDPS substance drugs under proper seizure by taking the signatures of witnesses and acknowledge by the accused person by putting his signature. The whole process of seizure and label was made in between 23.00 hrs to 23.35 hrs and arrested the above noted accused person U/S 41 CrPC informing the ground of his arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the said accused person namely 1) Pabitra Singha 24yrs s/o Ganesh Ch Singha Vill: Salkavita N.B.U, PS, Matigara Dist-Darjeeling and arrange for its investigation.
